**Vesting of Property and Scheme for the Administration relating to Endowment Fund for “Dr. Anton Goldwin Fernandez Gold Medal” for the best outgoing Student of MBBS Final Year in Kanyakumari Medical College, Kanyakumari under the Charitable Endowments Act.**

No. II(2)/HFW/596/2014.—In the matter of the Charitable Endowments Act, 1890 (Central Act VI of 1890) and in the matter of Endowment Fund for “Dr. Anton Goldwin Fernandez Gold Medal” for the best outgoing student of MBBS final year in Kanyakumari Medical College, Kanyakumari.

## I VESTING OF PROPERTY

Whereas an application has been made to the Government of Tamil Nadu under clause (b) of sub-section 1 of Section 6 of the Charitable Endowments Act, 1890 (Central Act VI of 1890) by St. Mary Health Educational and Research Trust, Nagercoil, the donor of the Endowment Fund specified above for vesting Rs.2,00,000/- (Rupees Two Lakhs only) in the Treasurer of Charitable Endowments appointed under the said Act for the State of Tamil Nadu. The Governor of Tamil Nadu, in exercise of the powers conferred by Section 4 of the said Act, hereby directs that the said amount be vested in the Treasurer aforesaid and be held by him and his successors-in office, subject to the provisions of the said Act and to any rules, which from time to time, may be or shall deemed to have been made thereunder, upon trust for the purpose and the subject to the conditions set forth in the Schemes settled under Section 5 of the said Act, for the Administration of the said Fund.

## II SCHEME FOR ADMINISTRATION

Whereas an application has been made to the Government of Tamil Nadu under Clause (b) of sub-section 1 of Section 6 of the Charitable Endowments Act, 1890 (Central Act VI of 1890) by St. Mary Health Educational and Research Trust, Nagercoil, the donor of the Endowment Fund specified above, for settling the Scheme for the administration of the said Fund. The Governor of Tamil Nadu in exercise of the powers conferred by Section 5 of the said Act, hereby settles the Scheme set forth in the schedule below for the administration of the said Fund

and appoint from the date of publication of this Notification in the *Tamil Nadu Government Gazette* as the date on which the Scheme as settled shall come into operation.

## SCHEDULE

1. The Endowment Fund shall be called as “Dr. Anton Goldwin Fernandez Gold Medal” for the best outgoing student of MBBS final year from the Kanyakumari Medical College in the memory of Dr. Anton Goldwin Fernandez, by St. Mary Health Educational and Research Trust, Nagercoil.

2. The Dean, Government Kanyakumari Medical College Asaripallam, Kanyakumari shall be the administrator of the Fund and shall deposit the amount furnished by the donor St. Mary Health Educational and Research Trust, Nagercoil with the Treasurer of Charitable Endowments, Government of Tamil Nadu, Chennai. Who will invest or reinvest the amount and proceeds in Government securities to the best interest of the Fund.

3. The interest accrued annually shall be utilized for purchase of Gold Medal every year and it shall be given to the best outgoing final year student of MBBS every year on the College Day.

4. In future, if the interest generated is not enough to make a Gold Medal, the authorities may inform to the Trust to enable them to contribute more funds for making the Gold Medal.

5. The student shall be a regular student and he shall earn more than 85% attendance in all the subjects.

6. The best outgoing student shall be selected by the Board of Examiners and its Chairman and recommended by the Dean, Kanyakumari Medical College, Kanyakumari. The recommendation shall be duly signed by the Chairman and Examiners and endorsed by the Dean, Kanyakumari Medical College, Kanyakumari.

7. The Managing Trustee of St. Mary Health Educational and Research Trust shall be one of the Members of Dr. Anton Goldwin Fernandez Gold Medal Committee of Kanyakumari Medical College.

Whereas complaints have been received from a number of depositors that Messers Green Life Farms & Poultry, Erode District, a financial establishment, has defaulted the return of deposits made by the depositors after maturity;

(3) Where the nature of work is the same, no distinction in the payment of wages shall be made between men and women employees.

(4) To arrive at the daily wages, the monthly wages shall be divided by 26.

(5) To arrive at the monthly rate wages, the daily rate shall be multiplied by 30.

(6) The total wage packet, that is, basic wages plus dearness allowance shall be the criterion for the purpose of compliance of this Notification.

(7) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
