ANIMAL HUSBANDRY DAIRYING AND FISHERIES DEPARTMENT

Amendment to the Special Rules for the Tamil Nadu Fisheries Service.

[G.O. Ms. No. 3, Animal Husbandry, Dairying and Fisheries (FS-2), 6th January 2014, Margazhi 22, Vijaya, Thiruvalluvar Aandu-2044.]

No. SRO B-5/2014.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Fisheries Service in Section 14 in Volume-II of the Tamil Nadu Services Manual, 1969.

2. The amendment hereby made shall come into force with effect from the 6th January, 2014.

AMENDMENT

In the said Special rules, in rule 4(b), under "THE TABLE", for the entries in Column 3 "Qualification", against the Category 3 "Deputy Director of Fisheries" in Column 1, the following entries shall be substituted, namely:—

"Must have put in a service not less than six years as Assistant Director of Fisheries in which two years of service must be in the marine sector".
