## NOTIFICATIONS BY GOVERNMENT

### LAW DEPARTMENT

#### Adhoc Rules relating to the Temporary Post of Markers in the Government Law Colleges in Tamil Nadu Basic Service.

#### No. SRO B-68/2014.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:—

(2) The rules hereby made shall be deemed to have come into force on and from the 7th August 2008.

#### RULES

The Special Rules applicable to the holders of the permanent posts in the Tamil Nadu Basic Service shall apply to the holders of the temporary post of Marker sanctioned from time to time, in the Government Law Colleges in the Department of Legal Studies subject to the modifications specified in the following Rules:—

2. **Constitution.**—The Post shall constitute a separate category in a distinct class of the said service.

3. **Appointment.**— Appointment to the post shall be made by direct recruitment.

4. **Appointing Authority.**— The appointing authority for the post shall be the Principal of the Government Law College concerned.

5. **Qualifications.**— (a) **Age.**— No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete fifty one years of age on the first day of July of the year in which the selection for appointment is made:—

Provided that candidates belonging to Scheduled Castes/Scheduled Tribes shall be eligible for appointment to the post, if he has not completed fifty six years of age and candidates belonging to Most Backward Classes / Denotified Communities shall be eligible for appointment to the post, if he has not completed fifty three years of age.

(b) **Other qualifications.**— No person shall be eligible for appointment to the post, unless he is able to read and write in Tamil.

6. **Savings.**— Nothing contained in these rules shall adversely affect the holders of the post on the date of coming into force of these rules.

7. **Pay.**— There shall be paid to the holder of the post, a monthly pay calculated in the Pay Band of Rs. 4800-10000 with Grade Pay of Rs. 1300.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu General Service, in Class LXXVIII.

1. The amendment (1) hereby made shall be deemed to have come into force with effect on and from the 7th November 1994.

2. The amendment (2) hereby made shall be deemed to have come into force with effect on and from the 23rd January 1998.

AMENDMENTS

In the said Special Rules, in Class LXXVIII,—

(1) *for* the expression “Personal Assistant (Household Supervision)” , the expression “Senior Superintendent” shall be substituted;

(2) *for* the expression “Senior Superintendent”, as so substituted the expression “Accounts Officer” shall be substituted.
