Shri S. Lakshmanan and Shri P. Ravindran, Inspector of Police, Operations, Special Division, SB CID, Chennai, Tamil Nadu were assigned a very important task of tracking and securing dreaded muslim extremist Fakruddin @ Fakruddin Ali Ahamed, Bilal Malik, Panna Ismail (Jihadi ideologists) wanted in several cases including planting of pipe bomb on L.K Advani's Rath Yatra route, murder of S. Vellaiappan, Hindu Munnani State Secretary, Auditor V. Ramesh, BJP State General Secretary and Bengaluru bomb blast. Timely intelligence coupled with agile and coordinated action taken by the said two Inspectors of Police, risking their life, lead to the arrest of Fakruddin Ali ahamed at Chennai, Tamil Nadu on 4-10-2013. Fakruddin Ali Ahamed was conducting recce to eliminate a Hindu organization leader at Chennai during the annual 'Tirupati Temple Thirukudai' procession. During his arrest, both the Inspectors were able to contain the stiff physical resistance posed by Fakruddin Ali Ahamed. The timely arrest of Fakruddin Ali Ahamed had prevented a break out of a major communal disharmony in the State. Due to unrelenting interrogation of Fakruddin Ali Ahamed, the team was able to gather information on the whereabouts of his associates Bilal Malik and Panna Ismail.

The team including Shri S. Lakshmanan, Inspector of Police went to the hideout of Bilal Malik and Panna Ismail at Puttur, Andhra Pradesh State in the wee hours on 5-10-2013 to nab them. They identified their hide out and surrounded their house at Muslim Street, Puttur. When the door was knocked by Inspector Shir S. Lakshmanan, posing as milkman, Bilal Malik opened the door. When Shri S. Lakshmanan tried to secure him, Bilal Malik and Panna Ismail dragged Shri S. Lakshmanan, inside their house, closed the door and started assaulting Shri s. Lakshmanan, with knife and sickle with a view to kill him. Lakshmanan resisted their assault. In the mean time, other police personnel made a valiant attempt to rescue Shir S. Lakshmanan and secure the accused. In this encounter Shri S. Lakshmanan, Inspector displayed conspicuous gallantry, courage and devotion to duty of a high order.

This award is made for gallantry under Rule 4(i) of the Rules governing the award of Police Medal and consequently carries with it the special allowance admissible under Rule 5, with effect from 5-10-2013.
