In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Notification issued with the Backward Classes and Most Backward Classes Welfare Department Notification No. SRO B-89/97, published at page 92 of Part III—Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 16th July 1997.

2. The Amendments hereby made shall be deemed to have come into force on and from the 5th August 1993.

AMENDMENTS

In the said Notification,—

(1) in the preamble, for the expression, "Section 82 in Volume- II of the Tamil Nadu Services Manual, 1969", the following expression shall be substituted, namely:—
