No. II(2)/EF/184/2015.—Whereas the Government of Tamil Nadu considers that the area of Oussudu Lake in Putturai and Perambai Villages in Vanur Taluk in Villupuram District described in the Schedule below is of adequate ecological, faunal,floral and Geomorphological Significance for the purpose of protecting, propagating and developing wild life and its environment.
