Amendments to the Special Rules for the Tamil Nadu Police Subordinate Service.

[G.O. Ms. No. 842, Home (Police-VI), 19th November 2014, கார்த்திகை 3, ஜய, திருவள்ளுவர் ஆண்டு–2045.]

No. SRO B-3/2015.

In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following Amendment to the Special Rules for the Tamil Nadu Police Subordinate Service (Section 34 in Volume II of the Tamil Nadu Services Manual, 1986).

AMENDMENT

In the said Special Rules, in rule 14, in sub-rule (i), after the proviso, the following proviso shall be added, namely:-

"Provided that all the physical measurements prescribed in Annexure-II shall be rounded off to the nearest centimeter or the nearest 0.5 centimeter, as the case may be".

In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act II of 1888), read with the proviso to Article 309 of the Constitution of India the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Police Subordinate Service (Section 34 in Volume-III of the Tamil Nadu Services Manual, 1986), as subsequently amended:—

2. The Amendments hereby made shall be deemed to have come into force on the 26th December 2012.

AMENDMENTS

In the said Rules,-

(1) in rule 3, after sub-rule (b), the following sub-rule shall be inserted, namely:-

"(c) No Sub-Inspector of Police (Finger Print) shall be eligible for promotion to the post of Inspector of Police (Finger Print) unless he has passed the Examination of Finger Print Experts of the Central Finger Print Bureau, National Crime Records Bureau, New Delhi."; and

(2) in ANNEXURE II, in the tabular column, in column (3) against the expression "Category 2, Sub-Inspectors of Police Category 2-A, Sub-Inspectors of Police (Finger Print) (Men and Women)" in column (1), in Clause (3), in sub-clause (i), the proviso to item (a) shall be omitted.

In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following amendments to the Special Rules for the Tamil Nadu Police Subordinate Service (Section 34 in Volume-III of the Tamil Nadu Services Manual, 1986), as subsequently amended.

2. This Amendments hereby made shall be deemed to have come into force with effect on and from the 15th December 2014.

AMENDMENTS

In the said Special Rules,-

(1) in rule 12-A, for the expression "category of Junior Reporter of the Shorthand Bureau", the expression "Categories of Sub-Inspectors of Police (Finger Print) and Junior Reporter of the Shorthand Bureau" shall be substituted;

(2) in Annexure I, in the tabular Column,-

(a) for the entry in Column 4, against the entry "Category 1A Inspector of Police (Finger Print)" in column (1), the entry "Inspector General of Police, State Crime Records Bureau," shall be substituted;

(b) in Column 3, against the entry "Category 2-A Sub-Inspectors of Police (Finger Print)" in column (1), the following expression shall be added, namely:-

"Not more than twenty per cent of vacancies shall be filled up from among the members of the Service in categories 7 and 8 in Class-I of rule 2 and from among the members holding the posts in categories 4, 5 and 6 of rule 2 of the Tamil Nadu Special Police Subordinate Service Rules:

Provided that if departmental candidates are not available to fill up the above twenty per cent vacancies, then the unfilled Vacancies shall be filled up by eligible candidates from open market:

Provided further that the provisions of rule 21 (b) of the General Rules for the Tamil Nadu State and Sub-ordinate Service shall apply in respect of reservation for women";

(c) for the entry in column 4, against the entry "Category 2A Sub-Inspectors of Police (Finger Print)" in column (1), the entry "Inspector General of Police, State Crime Records Bureau" shall be substituted;

(3) in Annexure II, in the Tabular column, under Class-I, in column (3), against the entry "Category-2A, Sub-Inspector of Police (Finger Print) (Men & Women)" in column (1),-

(i) in clause (1),-

(a) to sub-clause (i), the following proviso shall be added, namely:-

"Provided that in respect of male candidates for selection to the post of Sub-Inspector of Police (Finger Print), the height must not be less than 163 centimeters and in the case of Scheduled Caste or Scheduled Tribe candidates the height must not be less than 160 centimeters.";

(b) to sub-clause (ii), the following proviso shall be added, namely:-

"Provided that in respect of female candidates for selection to the post of Sub-Inspector of Police, (Finger Print), the height must not be less than 154 centimeters and in the case of Scheduled Caste or Scheduled Tribe candidates, the height must not be less than 152 centimeters.";

(c) to sub-clause (iii), the following proviso shall be added, namely:-

"Provided that there shall be no chest measurement for all candidates, that is, both men and women for selection to the post of Sub-Inspector of Police (Finger Print)".;

(ii) in clause (3), in sub-clause (i), in item (c), after the first proviso, the following provisos shall be inserted, namely:-

"Provided further that for selection to the post of Sub-Inspector of Police (Finger Print), there shall be no Physical Endurance Test and Physical Efficiency Test in respect of non departmental candidates and there shall be no Physical Measurement Test, Endurance Test and Physical Efficiency Test in respect of department candidates:

Provided also that in respect of the post Sub-Inspector of Police (Finger Print) the total marks reckoned for selection will be only 85, as the said post is exempted from Physical Efficiency Test".

"(2) (i) For appointment to the post of Sub-Inspector of Police, must posses a degree obtained from any University or Institution recognized by the University Grants Commission and for appointment to the post Sub-Inspector of Police (Finger Print), must posses a degree in Science from any University or Institution recognized by the University Grants Commission.

(ii) Must have the ability to read and write any one of the following languages, namely, Tamil, Telugu, Malayalam, Kannada and Hindustani" .
