2. The Office of the Chief Judicial Magistrate, Tirunelveli, Official Receiver, Tirunelveli and District Munsif *cum* Judicial Magistrate, Shencottah, Nanguneri, Cheranmahadevi and Sivagiri will remain open throughout the vacation and holidays declared above.
