No.II(2)/HOU/636/2015.—In exercise of the powers conferred by sub-section (4) of Section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby makes the following variations to the Development Regulations of Second Master Plan for the Chennai Metropolitan Area, 2026 approved under the said Act and published with the Housing and Urban Development Department Notification No. II(2)/HOU/386(e)/2008 of Part II—Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 2nd September 2008.

VARIATIONS.

(2) in regulation 24, in sub-regulation (1), in item (a), in sub-item (ii), for the expression “15.25 metres”, “30 metres”, the expression “17.0 metres”, “30.5 metres”, shall, respectively, be substituted;

(3) in regulation 26,—

(i) in sub-regulation (3), in Table A, Table B and Table C, for the expression “15.25 m” wherever it occur, the expression “17.0 m” shall be substituted;

(ii) in sub-regulation (4) in the Table, for the expression "15.25 m", wherever it occur, the expression "17.0 m" shall be substituted.

(4) in regulation 27, in sub-regulation (3), in the Table against Sl.No. "C" in column (1) and against the entry "Maximum Height" in Column (2), for the expression "15.25 m", the expression "17.0 m", shall be substituted;

(5) in Annexure XI, under the heading "B"-Permissible with the special sanction of the CMDA:—

(i) in item "(xiv)", for the expression "15 m", the expression "17 m", shall be substituted;

(ii) in item (xvii), in sub-items (a) and (b), for the expression "15 metres", "15.25 m", the expression "17.0 metres", shall respectively be substituted.
