Amendment to the Tamil Nadu Prison Rules.

[G.O. Ms. No. 719, Home (Prison V.), 12th October 2015, புரட்டாசி 25, மன்மத, திருவள்ளூர் ஆண்டு-2046.]

No. SRO A-18/2015.—In exercise of the powers conferred by Section 59 of the Prisons Act, 1894 (Central Act IX of 1894), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Prison Rules, 1983, as subsequently amended:—

AMENDMENT

In the said Rules, in rule 30, in sub-rule 34, in clause (b), for the expression “in the Districts under his control”, the expression “situated in those Districts, which are not having District Jails within the Jurisdiction of that respective Central Prison” shall be substituted.

LABOUR AND EMPLOYMENT DEPARTMENT

Amendment to the Tamil Nadu Industrial Disputes Rules

[G.O. Ms. No. 157, Labour and Employment (D2), 1st October 2015, Purattasi 14, Manmadha, Thiruvalluvar Aandu-2046.]

No. SRO A-19/2015.—In exercise of the powers conferred by sub-section (1) of Section 38 of the Industrial Disputes Act, 1947 (Central Act XIV of 1947), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Industrial Disputes Rules, 1958, the draft of the same having been previously published as required by the said sub-section (1) of Section 38 of the said Act.

AMENDMENT

In the said Rules, in rule 43, after sub-rule (2), the following sub-rule shall be added, namely:-

“(3) A Labour Court or Tribunal shall also have all the powers of a civil court under Order XXI of the Code of Civil Procedure, 1908 (Central Act V of 1908) to execute its own award or any settlement as defined in clause (p) of Section 2 of the Act, as a decree of a civil court.”.
