In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Co-operation, Food and Consumer Protection Department Notification No. SRO B-77/2015 on page 114 of Part III—Section 1(b) of the Tamil Nadu Government Gazette, dated the 7th October 2015:—

AMENDMENTS.

In the said Rules-

- 1. for rule 3, the following rule shall be substituted, namely:-
- "3. **Appointment**:- Appointment to the post shall be made by recruitment by transfer from among the holders of the post of District Judge (Entry Level) in category 3 in the Tamil Nadu State Judicial Service";
 - 2. rule 5 and rule 6 shall be omitted;
 - 3. for rule 7, the following rule shall be substituted, namely:-
- "7. Pay:- There shall be paid to the holder of the post a monthly pay calculated in the Scale of Rs. 55150-1230-58930-1380-63070".

Adhoc Rules relating to the Temporary post of Additional Secretary (Editor of Debates) in Tamil Nadu Legislative Assembly Secretariat Service.

In exercise of the powers conferred by clause (3) of Article 187 of the Constitution of India, the Governor of Tamil Nadu, after consultation with the Speaker of the Tamil Nadu Legislative Assembly, hereby makes the following rules:-

The rules hereby made shall be deemed to have come into force on the 7th May 2015.

Rules

The Rules applicable to the holders of the permanent post in Class - 1 of the Special rules for the Tamil Nadu Legislative Assembly Secretariat Service shall apply to the holder of the temporary post of Additional Secretary (Editor of Debates) in the Tamil Nadu Legislative Assembly Secretariat Service, subject to the modifications specified in the following rules:-

- 2. Constitution:- The post shall constitute a distinct category in the said Class of the said service.
- 3. **Appointment**:- Appointment to the post shall be made by promotion from among the holders of the post of Joint Secretary (Editor of Debates) in the Tamil Nadu Legislative Assembly Secretariat Service.
 - 4. Appointing Authority:- The appointing authority for the said post shall be the Governor of Tamil Nadu.
- 5. **Pay**:- There shall be paid to the holder of the post a monthly pay calculated in the scale of pay of Rs.37,400-67,000 Pay Band 4 with Grade pay of Rs. 9,500/-
