[Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997) - Messers Madurai Rural Development Transformation India Private Limited and Madurai Rural Development Benefit Fund India Limited, Madurai District, Default in return of deposits by the Financial Establishment - Ad-interim order attaching the movable properties of the said financial establishment under Section 3 of the said Act - Orders - Issued.]

From the Additional Director General of Police, Economic Offences Wing, Chennai, Letter No. C1/10432/2014, dated 07-11-2014.

Order No. 721, Home (Police XIX), 12th October 2015.

Whereas, complaints have been received from a number of depositors that Messers Madurai Rural Development Transformation India Private Limited and Madurai Rural Development Benefit Fund India Limited and its sister concern, Madurai District, financial establishments, have defaulted the return of deposits made by the depositors after maturity;

And whereas, the Government are satisfied that the said financial establishments are not likely to return the deposits to the depositors and hence, the Government have to protect the interests of such depositors;

And whereas, the movable properties specified in the Schedule to this order are alleged to have been procured by the said financial establishments from and out of the deposits collected from the depositors;

Now Therefore, in exercise of the powers conferred by section 3 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997), the Governor of Tamil Nadu hereby makes an ad-interim order attaching the movable properties (i.e) Bank frozen amount of Messers Madurai Rural Development Transformation India Private Limited and Madurai Rural Development Benefit Fund India Limited, Madurai District, as specified in the Schedule to

this order and transfers the control over the said movable properties to the Competent Authority, namely, the Competent Authority and District Revenue Officer, Madurai District appointed under the said Act.

2. The Competent Authority and District Revenue Officer, Madurai District, is requested to pursue further action in accordance with the procedure laid down in sub-sections (3) and (4) of section 4 of the said Act and also the formalities prescribed in the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Rules, 1997.

3. The Special Public Prosecutor, Special Court for the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997) Madurai District, is requested to render necessary assistance to the Competent Authority for filing the application before the said Special Court.

Exemption to the permanent employees of the T.N. Abdul Kader Noor Sait Beedi Company, Tirunelveli for certain period under the Employees' State Insurance Act.

No.II(2)/LE/690/2015.—In exercise of the powers conferred by Section 87 & 88, read with Section 91-A of the Employees' State Insurance Act, 1948 (Central Act XXXIV of 1948), the Governor of Tamil Nadu hereby exempts the permanent employees of the T.N. Abdul Kader Noor Sait Beedi Company, Tirunelveli from the operation of the said Act for the period from 22-10-2015 to 21-10-2016.

(1) The above exemption is subject to the following conditions, namely:—

- The aforesaid Management wherein the employees are employed shall maintain a Register showing the names and designations of the exempted employees.
- Notwithstanding the exemption, the employees shall continue to receive such benefits under the said Act

to which they might have become entitled to on the basis of the contributions paid prior to the date from which exemption granted by this Notification operates.

(c) The contribution for the exempted period, if already paid shall not be refunded.

(2) The employer of the said Management shall submit in respect of the period during which that Management was subject to the operation of the said Act (hereinafter referred to as "the said period") returns in such form and containing such particulars as were due from it in respect of the said period under the Employees State Insurance (General) Regulations, 1950.

(3) Any Social Security Officer appointed by the Corporation under sub-section (1) of Section 45 of the said Act, or other official authorised in this behalf shall, for the purpose of,-

(i) verifying the particulars contained in any return submitted under sub-section (1) of Section 44 of the said Act for the said period; or

(ii) ascertaining whether registers and records were maintained as required by the Employees State Insurance (General) Regulations, 1950 for the said period; or

(iii) ascertaining whether the employees continue to be entitled to the benefits provided by the employer in cash and in kind, being benefits in consideration of which exemption is being granted under this Notification; or

(iv) ascertaining whether any of the provisions of the said Act had been complied with during the period when such provisions were in force in relation to the said managements be empowered to,-

(a) require the principal or immediate employer to furnish to him such information as he may consider necessary; or

(b) enter any management, office or other premises occupied by such principal or immediate employer at any reasonable time and require any person found in charge thereof to produce to such Social Security Officer or other official and allow him to examine such documents, books and other documents relating to the employment of persons and payment of wages or to furnish to him such information as he may consider necessary; or

(c) examine the principal or immediate employer, his agent or servant, or any person found in such management office or other premises, or any person when the said Social Security Officer or other official has reasonable cause to believe to have been an employee; or

(d) make copies of or take extracts from any register, account book or other document maintained in such management, office or other premises.
