Amendment to the Special Rules for Tamil Nadu Police Subordinate Services.

In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888), read with the proviso to Article 309 of the Constitution of India the Governor of Tamil Nadu hereby makes the following Amendments to the Special Rules for the Tamil Nadu Police Subordinate Service (Section 34 in Volume-III of the Tamil Nadu Services Manual, 1986), as subsequently Amended:-

AMENDMENT

In the said Rules, in Annexure II, under Class I, in column (3),-

(1) against the entry "Category 2 Sub-Inspectors of Police Category-2A Sub-Inspector of Police (Finger Print) (Men and Women)" in column (1),-

(*i*) in Clause 1, in sub-clause (iii), after the expression "with a minimum chest expansion of 5 Centimetres.", the expression "The Ex-Servicemen and Ex-Personnel of Central Paramilitary Forces Candidates are exempted from height and chest measurement standards." shall be inserted;

(ii) in Clause 3,-

(a) in sub-clause (i), after the expression "that is running 1500 metres in 7 minutes.", the expression "Every Ex-Servicemen and Ex-Personnel of Central Paramilitary Forces candidates who have passed the written test shall undergo an endurance test, i.e. running 1500 metres in 8 minutes." shall be inserted;

(b) after the Table under the heading "For Women Candidates" and the entries thereunder, the following Table and entries shall be inserted, namely:-

"For Ex-servicemen and Ex-Personnel of Central Paramilitary Forces candidates

Out of the said five events, the candidates shall Participate in three events namely, one jump event, one running event and the shot put event and shall qualify in ail the three events with a minimum of one star in each of the events."

2. Against the entry "Category 5 Sub-Inspector (Armed Reserve) other than Band Master, Office of the Director General of Police, Chennai" in Column 1,-

(i) in clause 1, after Sub-clause (iii), the following sub-clause shall be added, namely:-

"(*iii-a*) The Ex-Servicemen and Ex-Personnel of Central Paramilitary Forces candidates are exempted from height and chest measurement standards.";

(ii) in clause 3,-

(a) in sub-clause (ii), after the expression "that is running 1500 meters in 7 minutes.", the expression "every Ex-Servicemen and Ex-Personnel of Central Paramilitary Forces Candidates who have Passed the written test shall undergo an endurance test, i.e., running 1500 meters in 8 minutes." shall be inserted;

(b) after the Table under the heading "For Women Candidates" and the entries thereunder, the following Table and entry shall be inserted, namely:-

"For Ex-Servicemen and Ex-Personnel of Central Paramilitary Forces candidates

Amendment to the Special Rules for Tamil Nadu Police Subordinate Service.

In exercise of the powers Conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859, (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III 1888) read with the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Special Police Subordinate Service Rules, 1978 (Section 44 in Volume III of the Tamil Nadu Service Manual, 1986):-

Amendment

In the said Rules,-

(1) after rule 1, the following rule shall be inserted, namely:-

"i-A. Eligibility.- Only male candidates are eligible for appointment to this service.";

- (2) in rule 9-B, the expression "(Men and Women)" occurring in the two places, shall be omitted;
- (3) in rule 14,-
- (A) in sub-rule (a), in the tabular column,-
 - (a) in column (1), for the expression, "(1) Category 2 (Men and Women)", the expression "1) Category 2" shall be substituted;
 - (b) in column (2),-
 - (1) against the expression "(1) Category 2", as so substituted in column (1), the fourth proviso shall be omitted;
 - (II) against the expression "(2) Categories 4, 5 and 6" in column (1), the fourth proviso shall be omitted;
 - (III) against the expression "(3) Categories 2, 4, 5 and 6" in column (1),-

(*i*) in the first paragraph, for the expression "In respect of male candidates", the expression "In respect of every candidate" shall be substituted;

- (ii) in the first proviso to the first paragraph, the expression "male" shall be omitted; and
- (iii) the second paragraph and the proviso thereto shall be omitted;
- (B) in sub-rule (f), in the Table,-

(a) in column (1), for the expression "Category 2 Sub-Inspectors (Men and Women)", the expression "Category 2 Sub-Inspectors" shall be substituted;

(b) in column (2), against the expression "Category 2 Sub-Inspectors", as so substituted in column (1), in clause (2), in sub-clause (i),-

(I) for the paragraphs beginning with the expression "Every male candidate for appointment" and ending with the expression "computing marks for the selection to the post of women Sub-Inspector" the following paragraphs shall be substituted, namely:-

"Every candidate for appointment to the post shall attend the written test first and the selected candidates will be subjected to physical measurement test and the persons qualified in the physical measurement test alone shall be permitted to undergo the endurance test, that is, running 1500 metres in 7 minutes. The candidates who succeeded in the endurance test shall have to undergo the Physical efficiency test, which shall consist of five events specified in the Table below. Out of the said five events, a candidate shall participate in one jump event, one running event and the rope climbing event and shall qualify in all the three events with at least one star standard.";

(II) under the heading "THE TABLE",-

(i) the sub-heading "FOR MEN CANDIDTES" shall be omitted;

(*ii*) the sub-heading "FOR WOMEN CANDIDATES", the tabular column and the paragraph relating thereto shall be omitted;

(c) in column (1), for the expression "Category 6 Constables (Men and Women)", the expression "Category 6 Constables" shall be substituted;

(d) in column (2), against the expression "Category 6 Constables", as so substituted in column (1), in clause (2), in sub-clause (ii),-

(I) for the paragraphs beginning with expression "Every male candidate" and ending with the expression "computing marks for the selection to the post of Women Constable" the following paragraph shall be substituted, namely:-

"Every candidate for appointment to the post shall attend the written test first and the selected candidates will be subjected to physical measurement test and the persons qualified in the physical measurement test alone shall be permitted to undergo the endurance test, that is, running 1500 metres in 7 minutes. The candidates who succeeded in the endurance test shall have to undergo the Physicai efficiency test, which shall consist of five events specified in the Table below. Out of the said five events, a candidate shall participate in one jump event, one running event and the rope climbing event and shall qualify in all the three events with at least one star standard.";

(II) under the heading" THE TABLE" .-

(i) the sub-heading "FOR MEN CANDIDATES" shall be omitted;

(ii) the sub-heading "FOR WOMEN CANDIDATES", the tabular Column - and the paragraph relating thereto shall be omitted; and

(4) rule 16-B shall be omitted.
