No. SRO B-91/2015.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Engineering Subordinate Service (Section 8 in Volume-III of the Tamil Nadu Services Manual, 1970).

2. (1) The amendment 1 hereby made shall be deemed to have come into force on the 22nd February 1977.

(2) The amendments 2(a), 2(c) and 3 hereby made shall be deemed to have come into force on the 22nd December 1986.

(3) The amendment 2(b) hereby made shall come into force on the date of issue of this order.

1. for the expression "Supervisor" wherever it occurs, the expression "Junior Engineer" shall be substituted;

2. in Part I, in rule 2,-
