#### Amendment to the Special Rules for the Tamil Nadu Medical Service.

[G.O. Ms. No. 344, Health and Family Welfare (B2), 20th November 2015, Karthigai 4, Manmadha, Thiruvalluvar Aandu-2046.]

No. SRO B-95/2015.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Medical Service (Section 21 in volume II of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall be deemed to have come into force on from the 6th July1993.

#### **A**MENDMENT

In the said Special Rules, in Part II, in Branch-I-Medical, for the expressions "Assistant Dental Surgeon" and "Assistant Dental Surgeons" wherever they occur, the expressions "Assistant Surgeon (Dental)" and "Assistant Surgeons (Dental)" shall, respectively, be substituted.

### Amendments to the Tamil Nadu Special Police Subordinate Service Rules.

[G.O. Ms. No. 837, Home (Police.IX), 20th November 2015, கார்த்திகை 4, மன்மத, திருவள்ளுவர் ஆண்டு–2046.]

No. SRO B-96/2015.—In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Special Police Subordinate Service Rules (Section 44 in Volume III of the Tamil Nadu Services Manual, 1986), as subsequently amended:—

#### AMENDMENTS

In the said Rules,-

- (1) in rule 7, in sub-rule (a), in the Table, in column (2), against the entry "6(a) Constables (other than those mentioned in (b) to (h) below)" in column (1), for clause (1), the following clauses shall be substituted namely:—
- "(1) By absorption of members of the Tamil Nadu Special Police Youth Brigade who have successfully qualified in the common state-level written examination conducted by the Tamil Nadu Uniformed Services Recruitment Board under rule 6 of the Tamil Nadu Special Police Youth Brigade Rules, 2013, based on merits and availability of vacancies, subject to communal reservation:
  - (1-A) If no suitable candidate is available for appointment by the above method, by direct recruitment; (or)";
- (2) in rule 14, in sub-rule (f), in the Table, in column (2), against the entry "Category 6 Constables" in column (1), in clause (2), after sub-clause (ii), the following explanation shall be added, namely:—
- "Explanation.- This rule shall not apply to appointment to the post by absorption of members of the Tamil Nadu Special Police Youth Brigade,"; and
  - (3) in rule 16, to sub-rule (1), the following proviso shall be added, namely:—
- "Provided further that a person appointed as constable by absorption of the members of the Tamil Nadu Special Police Youth Brigade shall undergo six months of basic institutional training followed by one month practical training".

#### Amendment to the Special Rules for the Tamil Nadu Jail Subordinate Service.

[G.O. Ms. No. 902, Home (Prison-2), 14th December 2015, கார்த்திகை 28, மன்மத, திருவள்ளுவர் ஆண்டு–2046.]

No. SRO B-97/2015.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Jail Subordinate Service (Section 17 in Volume III of the Tamil Nadu Services Manual, 1970).

#### **A**MENDMENT

In the said Special Rules, in Part II, under the heading "Branch I- Executive Staff", to rule 6, the following proviso shall be added, namely:-

"Provided that all the physical measurements prescribed in the Annexure shall be rounded off to the nearest centimeter or the nearest 0.5 centimeter, as the case may be.".

No. SRO B-98/2015.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Engineering Subordinate Service (Section 8 in Volume III of the Tamil Nadu Services Manual, 1970).

- 2. Amendment (1) hereby made shall be deemed to have come into force on the 1st November 1995.
- 3. Amendment (2) hereby made shall be deemed to have come into force on the 1st November 2013.

#### **A**MENDMENTS

In the said Special Rules, in Part II, under the heading "Branch I- Engineering Branch", in SCHEDULE I referred to in rule 3, -

(1) for the entries "Chief Engineer (Irrigation)" in column (2) against the entries "Senior Research Assistants" and "Junior Research Assistants" in column (1) thereof, the following entries shall be substituted, namely:-

"Chief Engineer, Design, Research and Construction Support, Chennai";

(2) for the entries "Chief Engineer, Design, Research and Construction Support, Chennai" as so substituted in column (2) against the entries "Senior Research Assistants" and "Junior Research Assistants" in column (1) thereof, the following entries shall be substituted, namely:-

"Chief Engineer, Plan Formulation, Chennai.".
