No. II(2)/HWMP/807/2015.—The Governor of Tamil Nadu having been satisfied that the lands in the schedule below are required for the purpose of Widening of East Coast Road to six lane from Thiruvanniyur to Akkarai and it having already been decided that the entire amount of Compensation to be awarded for the lands is to be paid out of the funds controlled and managed by the Divisional Engineer (H), Chennai Metropolitan Development Plan, Division-I, Guindy, Chennai – 32 and after having considered the cause shown by the owner or other person having interest in the said lands, as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act 2001 (TN Act 34 of 2002).
