## NOTIFICATIONS BY GOVERNMENT

### HOME DEPARTMENT

#### Amendments to the Special Rules for the Tamil Nadu Special Police Subordinate Service.

[G.O. Ms. No. 39, Home (Police-IX), 13th January 2015.]

No. SRO B-12/2015.—In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act 3 of 1888), read with the proviso to Article 309 of the Constitution of India and all other powers hereunto enabling the Governor of Tamil Nadu hereby makes the following Amendments to the Tamil Nadu Special Police Subordinate Service Rules, 1978:—

#### AMENDMENTS

In the said Rules,-

(1) in rule 7, in sub-rule (a), in the TABLE, in the second column,-

(a) against the entry “2 (a) Sub-Inspectors” in the first column, in the fifth proviso, for the expression “dependents of police personnel including ministerial staff of Police Department”, the expression “general pool” shall be substituted;

(b) against the entry “6(a) Constables (Other than those mentioned in (b) to (h) below)” in the first column, in the third proviso, for the expression “dependents of serving Police Personnel including Ministerial Staff of the Police Department”, the expression “the general pool” shall be substituted;

(c) in sub-rule (aaa), for the expression beginning with “shall be made by the selection committee” and ending with “shall be interviewed by the Selection Committee.”, the following expression shall be substituted, namely:—

“shall be made by the Tamil Nadu Uniformed Services Recruitment Board in accordance with rule 22 of Part-II General Rules of the Tamil Nadu State and Subordinate Services Rules.”; and

(2) in rule 14, in sub-rule (f), in the Table, in column (2), against the entry, “Category 6 Constables” in column 1, in clause (2), in sub-clause (ii), the first, second and the third provisos shall be omitted.

#### Amendments to the Ad-hoc Rules Relating to the Temporary Post of Joint Director of Industries and Commerce (Cost Accounting) in Tamil Nadu Industries Service.

No. SRO B-13/2015.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Industries Department Notification No. 431, dated 4th November 1992 at pages 194-195 of Part III—Section 1(b) of *The Tamil Nadu Government Gazette*, dated 4th November 1992.

2. The amendments hereby made shall come into force on the 22nd January 2015.

#### AMENDMENTS

In the said rules:-

(1) in rule 3, the following expressions shall be omitted, namely:—

“(or)

(iii) direct recruitment.

**Explanation:** Notwithstanding anything contained in clause (14) of rule 2 in Part I Preliminary of the General Rules for the Tamil Nadu State and Subordinate Service, regular members in any of the services of the Government of Tamil Nadu shall also be eligible for appointment to the post by direct recruitment.

(2) in rule 4,-

(i) sub-rule (a) shall be omitted;

(ii) in the "THE TABLE" under the heading "Method of appointment" in column (1), the expression "or direct recruitment shall be omitted;

(3) in rule 5, the expression "direct recruitment or" shall be omitted.

**Amendment to the Special Rules for the Tamil Nadu General Subordinate Service.**

No. SRO B-14/2015.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu General Subordinate Service (Section 13 in Volume III of the Tamil Nadu Services Manual, 1970).

2. The Amendment hereby made shall be deemed to have come into force on the 19th January 2015.

AMENDMENT

In the said Special Rules:-

in Part-I and Part-II, under "Class LXXII—School Education Department", for the expression "Laboratory Assistants in Higher Secondary Schools" wherever they occur, the expression "Laboratory Assistants in High Schools and Higher Secondary Schools" shall be substituted.
