Amendments to the Ad hoc Rules for the Electro Encephalographic Technician in the Tamil Nadu Medical Subordinate Services.

[G.O. Ms. No. 13, Health and Family Welfare (C2), 20th January 2015, தை 6, ஜய, திருவள்ளுவர் ஆண்டு–2046.]

No. SRO B-15/2015.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Ad hoc rules published with the Health, Education and Local Administration Department Notification No. SRO A-6244 of 1957, dated 11th September 1957, at page 1808 of Part I of the *Fort St. George Gazette*, dated 16th October 1957.

2. The amendments hereby made shall come into force from the date of issue of this order.

AMENDMENTS

In the said Rules,-

(1) for rule 5, the following rule shall be substituted,-

"No person shall be eligible for appointment to the post unless he/she possesses the following Qualification".

- (i) A pass in HSC with Science Subjects
 - (a) Physics, Chemistry, Botany and Zoology

(or)

- (b) Physics, Chemistry and Biology
- (ii) Must have passed the one year Certificate Course in EEG/EMG conducted in Government Medical Institutions under the Control of Director of Medical Education (or) in any other institution recognized by the State/Central Government.
- (2) In rule 7, after Proviso, the following Proviso shall be added, namely:-

"Provided further that on and from 1-06-1988, the monthly pay shall be calculated in the scale of pay Rs. 950-20-1150-30-1500".

"Provided further that on and from 1-06-1996, the monthly pay shall be calculated in the scale of pay Rs. 3050-75-3950-80-4590".

"Provided further that on and from 1-01-2006, the monthly pay shall be calculated in the scale of pay Rs. 5200-20,200+GP 2400".

- (3) After rule (7), the following shall be added:-
 - "8. Saving Clause: Nothing contained in these rules shall adversely affect any person holding the post as on date".

Amendment to the Special Rules for the Tamil Nadu General Service.

No. SRO B-16/2015.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu General Service (Section 16 in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendment hereby made shall be deemed to have come into force with effect from the 19th December 2013.

AMENDMENT

In the said Special Rules, in Class-XII, in the Annexure referred to in rule 3, for the entry "Must have rendered service for a period of not less than two years in the category of Strictly Confidential Deputy Section Officer in Public (SC) or Home (SC) Departments" in column (3), against the entry "3(a) Strictly Confidential Section Officers in Public (SC) Department, Home (SC) Department and in Governor's Secretariat" in column (1) and the entry "Recruitment by transfer from among the holders of the post of Strictly Confidential Deputy Section Officer in Public (SC) and Home (SC) Departments in the Tamil Nadu Secretariat Service" in column (2) thereof, the following entries shall be substituted, namely:-

- "(i) Must hold a Bachelor's Degree of any University recognized by the University Grants Commission for the purpose of its grant; and
- (ii) Must have rendered service for a period of not less than two years in the category of Strictly Confidential Deputy Section Officer in Public (SC) or Home (SC) Departments, as the case may be".
