Adhoc Rules Relating to the Temporary Post of Science Assistant in Seismological Observatory at Sholayar Nagar in Tamil Nadu Engineering Subordinate Service.

[G.O. Ms. No. 73, Public Works(D1), 26th February 2016, மாசி 14, மன்மத, திருவள்ளுவர் ஆண்டு–2047.]

No. SRO B-30/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules.

2. The rules hereby made shall be deemed to have come into force with effect on and from the 8th August, 1991.

Rules

The General and the Special Rules applicable to the holders of the permanent posts in Branch I of the Tamil Nadu Engineering Subordinate Service shall apply to the holder of the temporary post of Science Assistant in Seismological Observatory at Sholayar Nagar, subject to the modifications specified in the following rules:-

- 2. Constitution.- The post shall constitute a distinct category in the said branch of the said service.
- **3. Appointment.-** Appointment to the post shall be made by direct recruitment or for special reasons, by recruitment by transfer from any other service.
- **4.** (a) **Appointing Authority.-** The appointing authority for the post shall be the Chief Engineer(General), Public Works Department, Chennai.
- (b) **Transferring Authority.-** The transferring authority for the post shall be the Chief Engineer (General), Public Works Department, Chennai.
- **5. Qualifications.-** (a) **Age.-** No person shall be eligible for appointment to the post by direct recruitment if he has completed or will complete 30 years of age on the 1st day of July of the year in which the selection for appointment is made or notification issued, as the case may be.
- (b) Other Qualifications.- No person shall be eligible for appointment to the post unless he possesses a first or second class Master Degree in Physics.
- **6. Probation.-** Every person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

Provided that every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a period of one year on duty within a continuance period of two years.

- **7. Test.-** A probationer in the category of Science Assistant shall, within the period of his probation, pass the Account Test for Public Works Department Officers and Subordinates in Part-I and II conducted by the Tamil Nadu Public Service Commission.
 - 8. Pay.- There shall be paid to the holder of the post a monthly pay calculated in the scale of Rs.1640-60-2600-75-2900.

Adhoc Rules Relating to the Temporary Post of System Analyst in Special Programme Implementation Department in Tamil Nadu General Service.

No. SRO B-31/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rule hereby made shall be deemed to have come into force on the 27th February 2014.

Rules

The General and the Special Rules applicable to the holders of the permanent post of Section Officers constituted under category 3 of Class XII in the Tamil Nadu General Service shall apply to the holders of the temporary post of System Analyst, in the Special Programme Implementation Department, sanctioned from time to time subject to the modifications specified in the following rules:-

- 2. Constitution.- The post shall constitute a distinct category in the said Class in the said service.
- 3. Appointment.- Appointment to the post shall be made as follows:-
 - (i) by direct recruitment; or
 - (ii) by transfer from any other category of the same service; or
 - (iii) by recruitment by transfer from any other service.
- **4. Preparation of annual list of approved candidates.** For the purpose of preparation of annual list of approved candidates for appointment to the post the crucial date shall be the 1st September every year.
- **5. Appointing Authority.** The appointing authority for the post shall be the Secretary to Government, Special Programme Implementation Department.
- 6. Qualifications.- (a) Age.- No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete the age of thirty years on the first day of July of the year in which the selection for appointment is made or notification issued as the case may be.
- **(b) Other Qualification.** No person shall be eligible for appointment to the post unless he possesses the qualifications specified below:-
- B.E. Computer Science or Information Technology or M.C.A. or M.Sc (I.T.) with experience for a period of not less than two years in software.
- **7. Reservation of appointment.-** The rule relating to reservation of appointments (General Rule 22) shall apply for appointment to the post by direct recruitment.
- **8. Probation.-** (a) Every Person appointed to the post by direct recruitment, shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.
- (b) Every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.
- **9. Pay.-** There shall be paid to the holder of the post, a monthly pay calculated in the pay band 3 of Rs. 15600-39100 + Grade Pay Rs. 5400/-
