- (ii) Against the entry "**Agriculture**" the expression "590 to 602" the following entry "590 to 602 except (590/1A, 1B, 1C, 591/1, 2, 3)" shall be substituted.
- (iii) Against the entry "**Educational**" the expression "585/1, 585/2" shall be added.
- (iv) Against the entry "**Residential**" the expression "583/1,2,3,4, 584, 586/1A, 1B, 2, 590/1A, 1B, 1C, 591/1,2,3" shall be added after the entry 571.
