**FINANCE DEPARTMENT**
**Amendments to the Special Rules for the Tamil Nadu State Treasuries and Accounts Services.**

[G.O. Ms. No. 153, Finance (Treasuries and Accounts-I), 26th May 2016, Vaikasi 13, Thunmugi, Thiruvalluvar Aandu-2047.]

No. SRO B-37/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu State Treasuries and Accounts Services (Section 28A in Volume-II of the Tamil Nadu Services Manual, 1969).

2. The amendments hereby made shall be deemed to have come into force on the 10th August 2015.

**AMENDMENTS**

In the said Special Rules,—

1, in rule 3,—

(I) in sub-rule (a), in the TABLE, in column (2) under the heading “Method of Appointment”, in item (i) against the entry “Class II” in column (1) thereof, for the expression “Class III or”, the expression “Class III or Class III-A or” shall be substituted.

(II) in sub-rule (bb), the following sub-rule shall be substituted, namely:—

“(bb) Out of vacancies in Class II both permanent and temporary, seventy percent of the vacancies shall be filled up from among the holders of the post in Class III, ten per cent shall be filled up from among the holders of the post in Class III-A and twenty per cent of the vacancies shall be reserved for appointment by recruitment by transfer from the category of Section Officer of the Departments of Secretariat. The vacancies so reserved for the Section Officer of the Finance Department and the Section Officer under the one unit be in the ratio of 1.3. out of every twenty vacancies in Class II, appointment shall be made in the following order of rotation:—

1st to 7th Posts	Accounts Officers;
8th Post	Additional Treasury Officer;
9th Post	Section Officer (Finance Department);
10th Post	Section Officer (One unit);
11th to 17th Posts	Accounts Officers;
18th Post	Additional Treasury Officer;
19th and 20th Posts	Section Officer (One Unit).

The seniority of the persons selected to the post shall be fixed in the above cyclic order by which selection is made:

Provided that if no qualified candidate is available in the Finance Department, such vacancy shall be filled up by the Section Officer of the Departments of Secretariat other than Law and vice-versa:

Provided further that if no qualified candidate is available, either in the Finance Department or in the Departments of Secretariat other than Law, such vacancy shall be filled up by promotion from among holders of the post in Class III”.

Provided also that if no qualified candidate is available in the post of Additional Treasury Officer, such vacancy shall be filled up by promotion from the holders of the post in Class III”.

(2) in rule 5, in the 'TABLE' in "Class II", after the entry "By promotion from Class III" in column (2) and the corresponding entries in column (3) thereof, the following entries shall respectively be inserted, namely:—

By promotion from  
Class III - A

(a) Must be an approved probationer in the Post of Additional Treasury Officer.

(b) Must have passed B.Com./ Accountancy Senior Grade Examination."

#### **Ad hoc Rules relating to the Temporary Post of Senior Lecturer in Optometry at the Regional Institute of Ophthalmology and Government Ophthalmic Hospital, Chennai in Tamil Nadu Medical Subordinate Service.**

[G.O. Ms. No. 164, Health and Family Welfare (C2), 30th May 2016, வைகாசி 17, துன்முகி, திருவள்ளூர் ஆண்டு-2047.]

No. SRO B-38/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:—

2. The rules hereby made shall come into force on and from the 30th of May 2016.

#### RULES

The General and Special rules applicable to the holders of the permanent post under category 3 in class XIII of Branch IV General of the Tamil Nadu Medical Subordinate Services shall apply to the holders of the temporary posts of Senior Lecturer in Optometry, sanctioned from time to time to the Regional Institute of Ophthalmology and Government Ophthalmic Hospital, Chennai subject to the modifications specified in the following rules:-

2. **Constitution.**—The post shall constitute a separate category in the said class of Branch IV in the Tamil Nadu Medical Subordinate Services.

3. **Appointment.**—Appointment to the post shall be made by direct recruitment.

4. **Appointing Authority.**—The appointing authority for the post shall be the Director of Medical Education.

5. **Qualification.**—(a) **Age.**- No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete 30 years of age on the first day of July of the year in which the recruitment is made.

(b) **Other qualifications.**- No person shall be eligible for appointment to the post unless he possesses M.Sc., in Optometry awarded by any University recognized by the University Grants Commission:

Provided that other things being equal preference shall be given to candidates who possess M.Phil in Optometry or Ph.D., in Optometry.

6. **Reservation of appointments.**—The rule relating to the reservation of appointments (General Rule 22) shall apply for appointment to the post by direct recruitment.

7. **Probation.**—Every person appointed to the post by direct recruitment shall from the date on which he joins duty be on probation for a period of two years on duty within a continuous period of three years.

8. **Pay.**—There shall be paid to the holder of the post a monthly pay calculated in the pay Band of Rs.9300-34800 with Grade Pay of Rs.4600.
