#### Amendments to the Special Rules for the Tamil Nadu Ministerial Service.

No. SRO B-41/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume-III of the Tamil Nadu Services Manual, 1970).

2. The amendments hereby made shall be deemed to have come into force on the 1st March 2016.

#### AMENDMENTS

In the said Special Rules, in Annexure-XI, in rule 3, -

- (1) in sub-rule (a), clause (ii) shall be omitted;
- (2) in sub-rule (b), clause (i) shall be omitted.

### SPECIAL PROGRAMME IMPLEMENTATION DEPARTMENT

#### Adhoc Rules relating to the Temporary Post of System Analyst in Special Programme Implementation Department in Tamil Nadu General Service.

No. SRO B-42/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:—

2. The rules hereby made shall be deemed to have come into force on the 27th February 2014

#### RULES

The General and the Special Rules applicable to the holders of the permanent post of Section Officers constituted under category 3 of Class XII in the Tamil Nadu General Service shall apply to the holders of the temporary post of System Analyst, in the Special Programme Implementation Department, sanctioned from time to time subject to the modifications specified in the following rules:-

2. **Constitution.**—The post shall constitute a distinct category in the said class in the said Service.
3. **Appointment.**—Appointment to the post shall be made as follows:-
  - (i) by direct recruitment: or
  - (ii) by transfer from any other category of the same service; or
  - (iii) by recruitment by transfer from any other service.

4. **Preparation of annual list of approved candidates.**— For the purpose of preparation of annual list of approved candidates for appointment to the post the crucial date shall be the 1st September every year.

5. **Appointing Authority.**— The appointing authority for the post shall be the Secretary to Government, Special Programme Implementation Department.

6. **Qualifications.**- (a) **Age.**- No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete the age of thirty years on the first day of July of the year in which the selection for appointment is made or notification issued as the case may be.

(b) **Other Qualification.**- No person shall be eligible for appointment to the post unless he possesses the qualifications specified below:-

B.E. Computer Science or Information Technology or M.C.A. or M.Sc. (I.T) with experience for a period of not less than two years in Software.

7. **Reservation of appointment.**—The rule relating to reservation of appointments (General Rule 22) shall apply for appointment to the post by direct recruitment.

8. **Probation.**— (a) Every person appointed to the post by direct recruitment, shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

(b) Every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.

9. **Pay.**—There shall be paid to the holder of the post, a monthly pay calculated in the pay band 3 of Rs.15600-39100 + Grade Pay Rs. 5400/-.

**Amendment to the Adhoc Rules relating to the Post of Assistant Tourist Officer Grade-II in  
Tamil Nadu General Subordinate Service**

No. SRO B-43/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the rules published with the Information and Tourism Department Notification No. SRO B-461/84 at pages 568 to 572 of Part III—Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 26th December 1984.

2. The amendment hereby made shall be deemed to have come into force on the 12th day of August 2015.

AMENDMENT

In the said Rules, in rule 5, in sub-rule (b), in the Table, in column (2), against the post "Assistant Tourist Officer, Grade-II" in column (1) thereof, for the entries under the heading "(a) for direct recruitment,-", the following entries shall be substituted, namely:-

"(i) A degree in Travel and Tourism; or any degree with diploma in Tourism; and

(ii) Must have undergone Certificate course in Computer on Office Automation offered by the Department of Technical Education, Government of Tamil Nadu or any equivalent course offered by any institution recognized by Department of Electronics and Information Technology of Government of India - All India Diploma Programs or any higher level program in which office automation is a subject like DOEACC - 'O' level, 'A' level, etc;".
