No. SRO B-45/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Ad hoc rules published with the Health and Family Welfare Department Notification No.(SRO)B-45/2008 at Page 142 of Part III—(Section)1(b) of the *Tamil Nadu Government Gazette*, dated the 15th October 2008.

2. The Amendments hereby made shall come into force on the date of publication of this Notification in the Tamil Nadu Government Gazette.

Amendments

In the said rules,-

(1) For rule 3, the following shall be substituted, namely:-

"(3) Appointment.--Appointment to the post shall be made by direct recruitment."

(2) for rule 4, the following shall be substituted, namely:-

"(4) Appointing Authority.—The appointing authority for the post shall be the Commissioner of Indian Medicine and Homeopathy, Chennai."

(3) *in rule 5 in sub-rule* (b), for the expression "the Minimum General Educational Qualification", the expression "a Diploma in Nursing Therapy" shall be substituted.

(4) rule 6 shall be Omitted.

Amendments to the Tamil Nadu Special Police Subordinate Service Rules.

[G.O. Ms. No. 565, Home (Police IX), 2nd August 2016, ஆடி 18, துன்முகி, திருவள்ளுவர் ஆண்டு–2047.]

No. SRO B-46/2016.—In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the proviso to Article 309 of the Constitution of India and all other powers hereunto enabling the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Special Police Subordinate Service Rules, 1978 (Section 44 in Volume III of the Tamil Nadu Service Manual, 1986) as subsequently amended:-

AMENDMENTS

In the said Rules, in rule 14,-

(1) in sub-rule (a), in the tabular column, in column (2), against the entry "(3) Categories 2,4,5, & 6" in column (1), after the proviso, the following proviso shall be added, namely:-

"Provided further that the candidates belonging to the category of Ex-Servicemen and Ex-Personnel of Central Paramilitary Forces are exempted from height and Chest measurements in case of direct recruitment";

(2) in sub-rule (f), in the Table, in column (2),-

(a) against the entry "category-2 Sub-Inspectors" in column (1), in clause (2), in sub-clause (i), after the Table, the following proviso shall be inserted, namely:-

"Provided that every candidate belonging to the category of Ex-Servicemen and Ex-Personnel of Central Paramilitary Forces shall attend the written test first and the selected candidates shall be permitted to undergo an endurance test, that is running 1500 metres in 8 minutes. The candidates who succeeded in the endurance test shall have to undergo the physical effciency test, which shall consist of the five events specified in the Table below. Out of the said five events, a candidate shall participate in one jump event, one running event and the shot put event and shall qualify in all the three events with at least one star standard in each of the events.

"Provided that every candidate belonging to the category of Ex-Servicemen and Ex-Personnel of Central paramilitary Forces shall attend the written test first and the selected candidates shall be permitted to undergo an endurance test, that is, running 1500 metres in 8 minutes. The candidates who succeeded in the endurance test shall have to undergo the physical efficiency test, which shall consist of the five events specified in the Table below. Out of the said five events, a candidate shall participate in one jump event, one running event and the shot put event and shall qualify in all the three events with atleast one star standard in each of the events.

No. SRO B-47/2016.—In exercise of the powers conferred by clause (b) of sub-section (2) of Section 27 of the Tamil Nadu Fire service Act, 1985 (Tamil Nadu Act 40 of 1985) read with the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Fire Subordinate Service (Section 13 in Volume-II of the Tamil Nadu Services Manual, 1969):-

Amendments

In the said Special rules,-

1. in rule 5, after sub-rule (b), the following sub-rule shall be added, namely:-

"(c) All the physical measurements prescribed in Annexure-II shall be rounded off to the nearest Centimetre or the nearest 0.5 Centimetre, as the case may be";

2. in ANNEXURE-II, in the tabular column, in column (3) against the entry "Class II Category 5 (i) Fireman, Fireman Orderly, Fireman Messenger, Fireman Labourer, Fireman Sentry, Fireman Attendant" in column (1).-

(i) to clause (1), the following proviso shall be added, namely:-

"Provided that Ex-servicemen and Ex-Personnel of Central Para Military Forces are exempted from the above minimum physical standards";

(ii) in clause (4), after the table, the following proviso shall be added, namely:-

"Provided that the candidates belonging to the category of Ex-servicemen and Ex-personnel of Central Para Military Forces shall undergo an endurance test, that is, running 1500 Metres in 8 minutes. The candidates who succeed in the endurance test shall have to undergo the Physical Efficiency Test which shall consist of five events specified in the Table below and out of those five events, every candidate shall participate in three events and shall obtain minimum one star each in (i) shot put (ii) long jump or high Jump and (iii) 100 metres or 400 metres run.

No. SRO B-48/2016.—In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following amendment to the Special Rules for the Tamil Nadu Police Subordinate Service (Section 34 in Volume III of the Tamil Nadu Services Manual, 1986), as subsequently amended:-

Amendment

In the said Special Rules, after Rule 14, the following rules shall be inserted, namely:-

14-A Recruitment of Transgender Candidates:-

(1) A transgender candidate, who applies as Third Gender, shall be eligible for appointment in the vacancies reserved for women candidates as well as the vacancies under the general category.

(2) A transgender candidate, who applies as Third Gender, shall produce an Identity Card issued by the Transgenders Welfare Board.

(3) A transgender may choose to appear as male or female by selecting either of the Gender category at the time of application.

(4) If a transgender candidate applies as male candidate, then the requirement of Physical measurement Test, Physical Endurance Test and Physical efficiency Test prescribed for the male category shall apply.

(5) If a transgender candidate applies as female candidate, then the requirement of Physical Measurement Test, Physical Endurance Test and Physical Efficiency Test prescribed for the Female category shall apply.

(6) If a transgender apply as a Third gender, the Physical Measurement Test, Physical Endurance Test and Physical efficiency Test prescribed for female candidates shall apply to the Third gender candidates.
