Amendments to the Special Rules for the Tamil Nadu Ministerial Service in Employment and Training Department.

No. SRO. B-54/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume-III of the Tamil Nadu Services Manual, 1970).

2. The amendments hereby made shall be deemed to have come into force on the 12th June 2013.

AMENDMENTS

In the said Rules,-

(1) in rule 2,-

(i) under category-8, after the entry "Accountants in the Fisheries Department", the following entry shall be added, namely:-

"Accountant in the Training Branch of Employment and Training Department (Non-Technical) (One out of every two substantive vacancies)";

(ii) under category-12, after the entry "Assistant in the Technical Education Department (Non-Technical) (one out of every two substantive vacancies)", the following entry shall be added, namely:-

"Assistant in the Training Branch of Employment and Training Department (Non Technical) (One out of every two substantive vacancies)";

(iii) under category-16, for the entry "Store-keeper on Rs.705- 20-745-25-845-35-1230 in the Training Branch of the Employment and Training Department (25 per cent of the vacancies with the first vacancy going to the direct recruit in each cycle of 4 vacancies)", the following entry shall be substituted, namely:-

"Store Keeper in the Training Branch of Employment and Training Department (Non-Technical) (One out of every two substantive vacancies)";

(2) in rule 38, in sub-rule(b), in clause (ii), after the entry "16. Annexure- IX-O Technical Education Department", the following entry shall be added, namely:-

"17. Annexure-IX-P Training Branch of Employment and Training Department;"

(3) In Annexure-III referred to in sub-rule (a) of rule 30, under the heading "SPECIAL QUALIFICATIONS",-

(i) against the entry "12. Assistants and Accountants in the grade of Assistants in the Training Branch of the Employment and Training Department" in column (1), for the entry "Recruitment by transfer" and the entry "Must have passed the Special Test on Tamil Nadu Government Office Manual" in column (2) and column (3) thereof, the following entries shall, respectively, be substituted, namely:-

"Direct Must possess any Degree obtained from any University recognized by the recruitment University Grants Commission.

By promotion Must have passed the Special Test on the Tamil Nadu Government Office or by transfer Manual";

(ii) for the entry "16. Store-keeper on Rs.705-20-745-25-845- 35-1230 in the Training Branch of the Employment and Training Department" in column (1) and the corresponding entries "Direct recruitment" and "Must have passed the Pre-University Examination of any University or the Higher Secondary Examination (XII Standard)" in columns (2) and (3) thereof, the following entries shall, respectively, be substituted, namely:-

"16. Store-Keeper in Direct	Must possess any Degree obtained from any
the Training Branch	University recognized by the University Grants
of recruitment	Commission";

(4) in Annexure V, referred to in rule 34, under the heading "TESTS TO BE PASSED, TRAINING TO BE UNDERGONE OR OTHER QUALIFICATIONS TO BE ACQUIRED BY PERSONS APPOINTED TO THE SERVICE", under the heading "Employment and Training Department", under the sub-heading "Training Branch",-

(i) for the entires "Assistants and Accountants in the scale of pay of Rs.705-20-745-25-845-35-1230" and "Store-keepers in the grade of Assistants" in column (1) and the corresponding entries in columns (2) and (3) thereof, the following entries shall, respectively, be substituted, namely:-

"Assistants, Accountants and Store- Keepers.	Foundational Training for a period of two months at Civil Services Training Institute, Bhavanisagar.	Within the prescribed period of probation (or) Within two years from the date of appointment to the post, as the case may be."

(ii) under the entries as so substituted, the following proviso shall be inserted, namely:-

"Provided that every person appointed as Accountant and Store- Keeper by direct recruitment shall execute an agreement in proper Form with two sureties binding himself—

(i) agreeing to serve in the Training Branch of Employment and Training Department for a period of not less than five years; and

(ii) in case, he fails to serve as aforesaid, to refund to the State Government the total amount drawn by him as pay and allowances during the period of his training";

(5) after Annexure-IX-O, the following Annexure shall be inserted, namely:-

"ANNEXURE-IX-P

[Referred to in Rule 38(b)(ii)]

Appointment, Training, Conditions of Service of Directly Recruited Assistants (Non-Technical) in the Training Branch of Employment and Training Department.

1. Appointment to the service may be made in the category of Assistant (Non-Technical) in the Training Branch of Employment and Training Department by direct recruitment for employment in the State.

2. The number of vacancies in the State filled up under rule 1 shall not exceed in any year 50% of the total number of vacancies arising in the post of Assistant in the Training Branch of Employment and Training Department in that year.

3. The Joint Director (Craftsmen Training), Employment and Training Department shall be the appointing authority.

4. The rule of reservation of appointments (General Rule 22) shall apply to such appointments in the State.

5. No person shall be eligible for appointment as Assistant by direct recruitment, if he has completed or will complete the age of 30 years on the first day of July of the year in which the selection for appointment is made.

6. No person shall be eligible for appointment as Assistant by direct recruitment, unless he possesses a degree from any University recognized by the University Grants Commission.

7. Every person appointed as Assistant by direct recruitment shall be on probation for a total period of two years on duty within a continuous period of three years.

8. Every person appointed as Assistant by direct recruitment shall, within the period of probation,-

- (a) complete the Foundational Training for a period of two months at Civil Services Training Institute, Bhavani Sagar; and
- (b) pass the following tests, namely;-
 - (i) Account Test for Subordinate Officers, Part-I
 - (ii) Tamil Nadu Government Office Manual Test.

9. The inter-se-seniority between the directly recruited Assistants and the Assistants appointed by promotion or by transfer shall be as per the provisions laid down in rule 35(aa) of the General Rules for the Tamil Nadu State and Subordinate Services.

10. Consistent with his seniority, a directly recruited Assistant shall be eligible for promotion to any selection category posts, provided he has successfully completed his probation and has also passed the prescribed tests.

11. For every such person, so appointed, there shall be reserved a substantive vacancy arising in the permanent cadre of the category of Assistants in the Training Branch of Employment and Training Department. His appointment to a substantive vacancy shall not, however, confer on him any preferential claim for promotion.

12. The directly recruited Assistant shall be allowed straight away to draw the minimum of the scale of pay applicable to the post of Assistant. The training period shall be allowed to count for increment and for probation.

13. Every person appointed as Assistant by direct recruitment shall execute an agreement in proper Form with two sureties binding himself-

(i) to serve in the Training Branch of Employment and Training Department for a period of not less than five years; and

(ii) in case, he fails to serve as aforesaid, to refund to the State Government, the total amount drawn by him as pay and allowances during the period of training."

Amendments to the Special Rules for the Tamil Nadu Ministerial Service in Rural Development and Panchayat Raj Department

No.SRO.B-55/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume-III of the Tamil Nadu Services Manual, 1970).

2. The amendments hereby made shall be deemed to have come into force on the 29th October 2014.

Amendments

In the said Special Rules, in Annexure-IX-X,-

(1) for rule 3, the following rule shall be substituted, namely:-

"3 (i) the Director of Rural Development and Panchayat Raj shall be the appointing authority in respect of Office of the Director of Rural Development and Panchayat Raj, Chennai;

(ii) The Collectors of the respective Districts shall be the appointing authority in respect of Development Branches in the Collectorates, Offices of the Assistant Director (Panchayats), Assistant Director (Audit), Panchayat Union Offices taken together in each Revenue District and Regional Institute of Rural Developments in the Districts;"

(2) In rule 8, in clause (b), the following proviso shall be added, namely:-

"Provided that the directly recruited Assistants who have been recruited prior to 29th October 2014 shall be exempted from passing of the tests mentioned in item (i) and (iii) for the purpose of declaration of probation".
