### Adhoc Rules relating to the Temporary Posts of Dialysis Technician Grade-I and Grade-II Government General Hospital, Madras and Government Royapettah Hospital, Madras in Tamil Nadu Medical Subordinate Service.

[G.O. Ms. No. 189, Health and Family Welfare, 4th February 1984.]

No. SRO B-62/2016.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:--

The rules hereby made shall be deemed to have come into force on the 27th December 1979.

#### RULES

The General and Special Rules applicable to the holders of the permanent post in the Tamil Nadu Medical Subordinate Service shall apply to the holders of the temporary posts of Dialysis Technician Grade I and Grade II sanctioned from time to time for the Government Teaching Medical Institutions, subject to the modifications specified in the following rules:—

2. Constitution:—The posts shall each constitute a separate category in a distinct class of the said service.

3. **Appointment**:—Appointment to the posts specified on column (1) of the Table below shall be made by the methods specified in the corresponding entries in column (2) thereof:—

5. Qualification:—(a) Age:— No person shall be eligible for appointment to the posts by direct recruitment if he has completed or will complete the age as indicated against the posts mentioned below on the first day of July of the year in which selection for appointment is made.

2. The amendment hereby made shall be deemed to have come into force on and from the 25th March 2013.

#### AMENDMENT

In the said Special Rules, in rule 5, in the "TABLE", after item (iii) in column (2) against Category 3(d) "Assistants in the Finance Department" in column (1), the following provisios shall be added, namely:—

"Provided that fifty per cent of the vacancies shall be filled up by direct recruitment and the remaining fifty per cent of the vacancies shall be filled up by the other methods as follows:-
