In exercise of the powers delegated by the Government of Tamil Nadu in G.O. Ms. No.419, Housing and Urban Development Department, dated 1st June 1984 under Section 91 (2) of the Tamil Nadu Town and Country Planning Act, 1971 the Member-Secretary, Chennai Metropolitan Development Authority hereby makes the following variation under Sub-section (4) of Section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) to the Second Master Plan for Chennai Metropolitan Area 2026, approved in G.O. (Ms.) No.190, Housing & Urban Development (UD I) Department, dated 02.09.2008 and published as per G.O.(Ms) No.191, Housing & Urban Development (UD I) Department, dated 02-09-2008, as Housing and Urban Development Department Notification in No. 266 Part II—Section 2 of the *Tamil Nadu Government Gazette*, dated the 2nd September 2008.

VARIATION

In the said Second Master Plan in Development Regulations, in Regulation No. 12(2) the following shall be added:-

- (2) The expression “Map P.P.D. / M.P. II (V) No.19/2016” to be *read* with “Map No: MP-II/CITY 24/2008”.

2. The Offices of (i) the Fast Track Mahila Court, Thoothukudi, (ii) Chief Judicial Magistrate Court, Thoothukudi and (iii) Judicial Magistrate Court, Vilathikulam will remain open and function throughout the Vacation and holidays declared as stated above.

3. No Complaint or petition except application for grant of certified copies of documents etc., and Batta memos for service and execution of processes, will be received by the Civil Courts during the Vacation.

4. The Offices of the Copyists, Process Service and Execution Department shall be kept open throughout the Vacation. No arrest warrant shall be executed during the Vacation. The Offices of the other Department shall remain closed.

**Arrangements shall however be made.**

1. For functioning the necessary records and Original Orders to the Copyist and Process Service Department.
2. For submitting the records required to the High Court in pending proceedings.
3. For attending to all administrative correspondences.

In view of the instructions contained in the Criminal Rules of Practice and Circular Orders and as ordered in High Court's Circular R.O.P.2/64/C3, dated 29th April 1964, applications in urgent Criminal matters should be made to the High Court of Judicature at Madras. However arrangements for disposal of urgent criminal matters will be made if a Vacation Judge for disposing of them, is appointed by the High Court, Madras for this District.

Under Section 30 of the Tamil Nadu Courts Act as amended by Section 4 of the Tamil Nadu Act, 17 of 1959, if a Vacation Civil Judge is appointed to Thoothukudi District at Thoothukudi, Suits, Appeals and other proceedings on urgent nature will be received and disposed of by him in terms of the rules that may be framed in this regard.

**Constitution of Separate District Munsif Court at Andipatti by converting the existing District Munsif-cum-Judicial Magistrate Court, Andipatti and Constitution of Separate Judicial Magistrate Court, Andipatti.**

*(Roc. No. 2299/2012/G/Judn.)*

No. VI(1)/81/2016.

In exercise of the powers conferred by Section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) the High Court, Madras, hereby fixes Andipatti in Theni District as the place at which the District Munsif Court, Andipatti, shall be held.

In exercise of the powers conferred by Section 11 of the Tamil Nadu Civil Courts, Act, 1873 (Central Act III of 1873) the High Court, Madras, hereby directs that in Theni District, the District Munsif Court, Andipatti, shall have local jurisdiction over the entire Andipatti Taluk with effect from the date of constitution of separate District Munsif Court at Andipatti by converting the District Munsif-cum-Judicial Magistrate Court, Andipatti.

The High Court, Madras hereby directs and notifies that the District Munsif, Andipatti in Theni District shall exercise all the powers conferred on a District Munsif under Section 12 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) as amended up-to-date in regard to original suits and proceedings not otherwise exempted from his cognizance of which the amount or value of the subject matter does not exceed One Lakh Rupees within the local limits of his jurisdiction with effect from the date of constitution of separate District Munsif Courts at Andipatti by converting the District Munsif-cum-Judicial Magistrate Court, Andipatti.
