The following Notification GSR No. 1185 (E) dated the 30th December 2016 issued by the Government of India, Ministry of Shipping and published in Part II Section 3 sub-section (i) of the Extraordinary issue of the Gazette of India, dated 30th December 2016 is republished hereunder as required under Section 132(2) of the Major Port Trusts Act, 1963:-

**GSR No. 1185 (E).**—In exercise of the powers conferred by sub-section (i) of Section 124, read with sub-section (i) of Section 132 of the Major Port Trusts Act, 1963 (38 of 1963), the Central Government hereby approves the Chennai Port Trust Employees' (Grant of Advances for Festival and Natural Calamities) Amendment Regulations, 2016, made by the Board of Trustees for the Port of Chennai and are set out in the Schedule annexed to this Notification.

2. The said Regulations shall come into force on date of publication of this Notification in the Official Gazette.

CHENNAI PORT TRUST

**Chennai Port Trust Employees' (Grant of Advances for Festival and Natural Calamities)  
Amendment Regulations, 2016**

In exercise of the powers conferred by Section 28 of the Major Port Trusts Act, 1963 (38 of 1963), the Board of Trustees of the Chennai Port hereby makes the following Regulations further to amend the Chennai Port Trust Employees' (Grant of Advances for Festival and Natural Calamities) Regulations, 1994, namely:-

1. **Short Title and commencement:-**

(i) These Regulations may be called Chennai Port Trust Employees' (Grant of Advances for Festival and Natural Calamities) Amendment Regulations, 2016;

(ii) They shall come into force on the date of publication of the approval of the Central Government as required under the provisions of Section 124 and 132 of the Major Port Trusts Act, 1963, in the Gazette of India.

2. In the Chennai Port Trust Employees' (Grant of Advances for Festival and Natural Calamities) Regulations, 1994 the figure "Rs. 10000" appearing in Sub-Regulation (1) of Regulation 4, shall be substituted by the figure "Rs. 20000".
