4. The function of the State Variety Release Committee shall be to evaluate the varieties of seeds and to release these varieties. The tenure of office of the committee shall be for a period of 5 years with effect from the date of issue of this order. The Committee will normally meet once in a year to consider various matters falling within its purview. The Chairman of the Committee, shall hold at his discretion more than one meeting in a year to consider very important subjects if necessary. The proceedings of the committee shall be submitted to the Government by the Director of Agriculture immediately after every meeting. The head quarters of the Committee shall be at Chennai.

5. The members of the State Variety Release Committee shall draw daily allowance / travelling allowance as indicated below whenever they are called upon to attend the meeting of the State Variety Release Committee:-

- A. Official members shall draw travelling allowance and daily allowance in accordance with the rules of the State Government and the expenditure shall be debited to the head of account to which their pay and allowances are debited.
- B. The non-official members shall draw travelling allowance and daily allowance as applicably to first class committee.
- C. The Director of Agriculture is authorized to draw and disburse the Dearness Allowance & Travelling Allowance to the non-official members of the Committee.

6. The expenditure on travelling allowance and daily allowance of the non-official members shall be debited to the following head of account:-

"2401 - 00 - Crop Husbandry - 001 Direction and administration I non-plan - AA Agriculture Department - Head quarters Staff - 60 TA/DA to Non - Official members". (DPC No. 2401-00-001-AA-6003).

The Following Government order is published:—

1. G.O.Ms.No. 66, Environment and Forests (Ec.1) Department, dated 7-5-2013.
2. G.O.D.No.263, Environment and Forests (Ec.1) Department, dated 11-9-2014.
3. From the Member Secretary, Tamil Nadu Pollution Control Board Letter No.TNPCB/Law/LAI/32167/2013, Dated 25-7-2016 and 23-9-2016.

Order: No. 41, Environment and Forests (Ec.1), 27th March 2017.

Section 28 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 31 of Air (Prevention and Control of Pollution) Act, 1981 provides that the State Government may constitute a State Appellate Authority consisting of one or three persons as it may think fit, to be appointed to help in the adjudication of disputes relating to Environment and Pollution.

2. In pursuance of the orders of the Supreme Court in its Judgment in Civil Appeal No. 368-371 of 1999 of SLP (Civil) No. 10317-10320/98 and Civil Appeal Nos. 372, 373/99 in SLP (Civil) No.10380 & 13380/98 the Authority has been composed of a retired Judge of High Court as Chairman and Experts / Scientists in the field of Pollution Control as Members. Accordingly, the Appellate Authority for Tamil Nadu was constituted *vide* G.O.Ms.No. 208, Environment and Forests (EC.I) Department, dated 15-09-2000.

3. Accordingly, the Appellate Authority of Tamil Nadu Pollution Control Board was reconstituted *vide* G.O.Ms. No. 24, Environment and Forests (EC.I) Department, dated 08-02-2007 and in G.O.Ms.No. 66, Environment and Forests (EC.I) Department, dated 07-05-2013 orders have been issued extending the tenure of the Appellate Authority for a further period of three years from 19-02-2013 to 18-2-2016 and the Government also appoints Thiru. G. Rangasamy and Dr. K. Thanasekaran as the two experts/Scientists Members of the Appellate Authority for Tamil Nadu Pollution Control Board.

4. Further, in G.O.Ms.No. 20, Environment and Forests (EC.I) Department, dated: 17-2-16 the tenure of the Appellate Authority of Tamil Nadu Pollution Control Board was extended for a further period of three years from 19-02-2016 to 18-02-2019. However, the tenure of the members of Appellate Authority of Tamil Nadu Pollution Control Board was not extended since the proposal in this regard was not sent to the Government by the Tamil Nadu Pollution Control Board.

5. This Department has proposed to appoint two new expert members to the Appellate Authority of Tamil Nadu Pollution Control Board for the next tenure of three years since the tenure of members were already expired on 06-05-2016. Hence, the Chairman, Tamil Nadu Pollution Control Board was requested to furnish the list of experts / scientists name along with educational qualification, service details with Bio-data in the field of pollution control who is fit to be appointed as members to help in the adjudication of disputes relating to Environment and Pollution to the Appellate Authority of Tamil Nadu Pollution Control Board,

6. The Member Secretary, Tamil Nadu Pollution Control Board in his letter third read above has sent the 5 members of Experts / Scientists in the field of Pollution with their Bio - data for considering for selection and appointment as members for Appellate Authority and requested the Government to consider the proposal for appointing two members for the Appellate Authority of Tamil Nadu Pollution Control Board.

7. The Government after careful consideration appoints the following two Experts / Scientists members for the
