No.II(1)/CFCP/30/2017. —The following Order of the Government of India, Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs), New Delhi, the 25th August, 2017 is republished:-

**S.O. 2785 (E)** - In exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955), the Central Government hereby makes the following order further to amend the Removal of Licensing Requirements, Stock Limits and Movement Restrictions on Specified Foodstuffs Order, 2016, namely :-

**1. Short title and commencement.:-**

(1) This order may be called the Removal of Licensing Requirements, Stock Limits and Movement Restrictions on Specified Foodstuffs (Third Amendment) Order, 2017.

(2) It shall come into force on the date of its publication in the Official Gazette

2. In the Removal of Licensing Requirements, Stock Limits and Movement Restrictions on Specified Foodstuffs Order, 2016, in clause 3, in sub-clause (2), after the item (iii), the following item shall be inserted, namely :-

“(iv) Onion, for a period upto the 31st October, 2017.”
