Amendments to the Chennai Corporation General Service Rules.

[G.O. Ms. No. 116, Municipal Administration and Water Supply (MC-3), 14th November 2017, Aippasi 28, Hevilambi, Thiruvalluvar Aandu-2048.]

No.SRO A-52/2017.—In exercise of the powers conferred by clause (i) of sub-section (1) of Section 86 read with clause (a) of sub-section (2) of Section 347 of the Chennai City Municipal Corporation Act, 1919 (Tamil Nadu Act IV of 1919), the Governor of Tamil Nadu hereby makes the following amendments to the Chennai Corporation General Service Rules, 1970, as subsequently amended:-

- (2) (i) The amendments hereby made in respect of the post of Assistant Accounts Officer shall be deemed to have come into force with effect on and from the 31st of August, 2010;
- (ii) The amendments hereby made in respect of the post of Chief Reporter shall be deemed to have come into force with effect on and from the 30th April, 2015;
- (iii) The amendments hereby made in respect of the post of Sports Officer shall be deemed to have come into force with effect on and from the 27th May, 2015.

AMENDMENTS

In the said Rules,-

(1) in rule 2, against the entry "Class II", after "Category 3 ... Superintendent of Parks", the following categories shall be added, namely:-

"Category 4 Chief Reporter

Category 5 Sports Officer.";

- (2) in rule 3, in the Table under the heading Class II-(a), in column (2), against the entry Category-2 Assistant Accounts Officer in column (1),-
 - (i) for item (a), the following items shall be substituted, namely;-
 - "(a) By promotion from the category of Administrative Officer or Head Clerk in the Greater Chennai Corporation including Council Section in Class III who have put in not less than one year of service; or";
 - (ii) in item (b) the word "or" shall be added at the end;
 - (iii) after item (b), the following item shall be added, namely;-
 - "(c) By direct recruitment from among the members of the service;
 - (iv) in column (1) and (2), after the entry, "Category 3 Superintendent of Parks" in column (1) and the corresponding entries in column (2) thereof, the following entries shall, respectively, be added, namely:-
- "Category 4 By promotion from the Category of Reporter in Class III in the Corporation Chief Reporter Establishment who have put in not less than two years of service as such.
- Category 5 (a) By promotion from the post of Assistant Sports Officer in Class III of Corporation Sports Officer Establishment who have put in not less than two years of service as such;

or

- (b) By direct recruitment."
- (3) in rule 4, in the Table, -
 - (a) against the entry "5. Assistant Accounts Officer" in column (1),-
 - (i) for item (iii) in column (3) , the following item shall be substituted, namely:-

- "(iii) Must have served as Administrative Officer or Head Clerk in the Greater Chennai Corporation including Council Section in Class III for a period not less than one year.";
- (ii) in columns (2) and (3), after the entry "By promotion or by appointment on deputation" in column (2) and the corresponding entries in column (3) thereof, the following entries shall respectively, be added namely;-
 - "By direct recruitment A pass in the Charted Accountant or Cost and Works Accountant (Final).";
- (b) in columns (1) to (3), after the entry "6. Superintendent of Parks" in column (1) and the corresponding entries in columns (2) and (3) thereof, the following entries shall respectively, be inserted namely;-
 - "7. Chief Reporter
- By promotion from the category of Reporter.
- (i) Must have served as Reporter in the Corporation for a period of not less than two years;
- (ii) Must have passed Government Technical Examination in Typewriting Higher both Tamil and English;
- (iii) Must have Passed
 Government Technical
 Examination in Shorthand
 Tamil high speed Test;
- (iv) Must have passed Government Technical Examination in Shorthand both English and Tamil (or) Higher Grade in Tamil and Lower Grade in English (or) Higher Grade in English and Lower Grade Tamil; and
- (v) Must have passed Certificate Course in MS-Office (Windows).
- (i) Bachelor's degree in Physical Education;
- (ii) Must have served as Assistant Sports Officer in the Corporation for a period of not less than two years;
- (iii) A diploma in coaching of not less than ten months duration awarded by the National Institute of Sports, Sports Authority of India;
- (iv) Must have passed the Account Test for Executive Officers and Tamil Nadu Government Office Manual Test conducted by the Tamil Nadu Public Service Commission.

8. Sports Officer

By promotion from the category of Assistant Sports Officer.

By Direct recruitment

- (i) Bachelor's degree in Physical Education; and
- (ii) A diploma in coaching of not less than ten months duration awarded by the National Institute of Sports, Sports Authority of India; and
- (iii) Must be an outstanding sportsman in any discipline participated in National level Meets; and
- (iv) Must have experience in coaching activities for a period of not less than five years.";

- (4) in rule 6, -
 - (a) in sub-rule (a),-
 - (i) for the expression "Post of Secretary to the Council", the expression "Posts of Secretary to Council and Assistant Accounts Officer" shall be substituted;
 - (ii) the following sentence shall be added, namely:-

"Every person appointed by direct recruitment to the post of Sports Officer shall pass within his period of Probation, the Accounts Test for Executive Officers and the Tamil Nadu Government Office Manual Test conducted by the Tamil Nadu Public Service Commission.";

(b) in sub-rule (b), for the expression "Post of Secretary to Council", the expression "Posts of Secretary to Council, Assistant Accounts Officer and Sports Officer" shall be substituted.
