Amendment to Adhoc Rules Relating to the Temporary Post of Foreman Instructor (Enamels) in Tamil Nadu Industries Subordinate Service.

No. SRO B-18/2018.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules Published with the Industries Department Notification, SRO No.A-299 of 1972 dated the 16th February 1972, at pages 338-340 of Part V of the *Tamil Nadu Government Gazette*, dated the 12th April 1972.

2. The amendment hereby made shall come into force on the 20th February 2018.

Amendments to Adhoc Rules Relating to the Post of Head of Department in Government Polytechnics (Men and Women) in Tamil Nadu Educational Service.

No. SRO B-19/2018.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules Issued with the Education Department Notification S.R.O. No.A 117 of 1969, published at page 140 in Part V of the *Fort.St.George Gazette*, dated the 26th March 1969.

2. The amendments hereby made shall be deemed to have come into force on 25th May 2010.

AMENDMENTS

In the said Adhoc Rules, -

- (1) in rule 3,-
- (a) in item (i), the expression, "Workshop Superintendents, Superintendents (Sandwich) and Superintendents (Government Technical Higher Secondary Schools)" shall be omitted;
 - (b) item (ii) shall be omitted;
 - (2) in rule 5, -
 - (a) for items (I), (II) and (III) and the entries relating thereto, the following items and entries shall respectively be substituted, namely:-
 - (I) (i) A Bachelor's and Master's Degree in the appropriate branch of Engineering / Technology / Architecture with First Class or equivalent either at Bachelor's or Master's Degree Level; and
 - (ii) Experience for a period of not less than 10 years in the relevant field of Teaching / Research / Industry, in a position not below the rank of a Lecturer in Engineering Subjects, Workshop Superintendent and Superintendent (Sandwich) in a Polytechnic or equivalent grades in other Institutions:

Provided that in the case of Architecture branch, professional practice of not less than 10 years as certified by the Council of Architecture shall also be considered valid.

or

- (II) (i) A Bachelor's and Master's Degree in the appropriate branch of Engineering / Technology / Architecture with First Class or equivalent either at Bachelor's or Master's Degree Level; and
- (ii) Ph.D. or equivalent obtained from a recognised University in the appropriate discipline in Engineering / Technology/ Architecture; and
- (iii) Experience for a period of not less than 5 years in the relevant field of Teaching / Research / Industry, in a position not below the rank of a Lecturer in Engineering Subjects, Workshop Superintendent and Superintendent (Sandwich) in a Polytechnic or equivalent grades in other Institutions:

Provided that in the case of Architecture branch, professional practice of not less than 5 years as certified by the Council of Architecture shall also be considered as valid.

(b) after the last proviso, the following Explanations shall be added, namely:-

Explanations:-

- (i) Equivalence of Ph.D. shall be based on publication of 5 International Journal papers, each Journal having cumulative impact index of not less than 2.0, with incumbent as the main author and all the 5 publications being in the authors' area of specialization.
- (ii) Bachelor's Degree in the branch of Engineering / B.Tech./ M.E./ M.Tech./ Ph.D. shall be from a recognized University.
- (iii) In case of research experience, good academic record and technical books / research paper publications / Intellectual Property Rights / patents record shall be required.
- (iv) If the experience in industry is considered, the same shall be at the managerial level equivalent to that of Head of Department with active participation record in Designing, Planning, Executing, Analyzing, Quality Control, Innovation, Training, Technical Books / Research Paper Publications/ Intellectual Property Rights/ Patents Record.
 - (v) Flair for Management and Leadership shall be considered as essential.
- (vi) If a class / division is not awarded, minimum of 60% marks in aggregate shall be considered as equivalent to first class / division. If a Grade Point System is adopted, the Cumulative Grade Point Assessment shall be converted into equivalent marks as mentioned below:-

Amendments to Adhoc Rules Relating to the Post of Principal in Government Polytechnic Colleges (Men and Women) in Tamil Nadu Educational Service.

No. SRO B-20/2018.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules issued with the Education Department Notification S.R.O. No.A 173 of 1969, published at page 210 in Part V of the *Fort. St. George Gazette*, dated the 16th April 1969.

2. The amendments hereby made shall be deemed to have come into force on 25th May 2010.

AMENDMENTS

In the said Adhoc Rules, -

- (1) in rule 3,
 - clause (ii) shall be omitted;
- (2) for rule 5, the following shall be substituted, namely:-
- "5. Qualifications.- No person shall be eligible for appointment to the post by any of the methods specified in rule 3, unless he possess the following qualifications, namely"-
- "(i) (a) A Bachelor's and Master's degree in the appropriate branch of Engineering / Technology / Architecture with not less than sixty percent of marks or its equivalent either at Bachelor's or Master's degree; and
- (b) Ph.D from the appropriate discipline of Engineering / Technology / Architecture; or must have published five International Journal papers in the relevant areas of specialization, each Journal having a cumulative impact index of not less than 2.0, with incumbent as the main author and all the five publications being in the authors' area of specialization.
- (ii) Experience for a period of not less than ten years in the relevant field of research / industry / teaching, out of which, not less than three years shall be in a position not below the rank of Head of Department in a Polytechnic or in a equivalent grade in other Institution:

Provided that in the case of Architecture branch, professional practice of not less than ten years, as certified by the Council of Architecture, shall also be considered as a valid experience:

Provided further that in the case of persons belonging to a service, the period spent by them on acquiring higher qualifications in Engineering will be counted towards the experience in the particular category of posts held by them before proceeding for higher studies:

Provided also that for persons holding the post of Assistant Director of Technical Education (Examination) in the Directorate of Technical Education, the period of service rendered in that post shall be counted only once towards the required teaching experience in the category of Head of Department in the Government Polytechnics.

Explanations:-

- (a) In the case of research experience, good academic record and technical books / research paper publications / Intellectual Property Rights / patents record shall be required.
- (b) In the case of experience in industry, the same shall be at the managerial level equivalent to that of Head of Department with active participation in designing, planning, executing, analyzing, quality control, innovation, training, technical books / research paper publications / Intellectual Property Rights/patents record.

Flair for Management and Leadership shall be considered as essential.

(c) If a Grade Point System is adopted, in Bachelor's or Master's degree, the Cumulative Grade Point Assessment shall be converted into equivalent marks as mentioned below:-

Grade Point	Equivalent Percentage
6.25	55%
6.75	60%
7.25	65%
7.75	70%
8.25	75%

- (3) for rule 10, the following shall be substituted, namely :-
- 10. Savings.- "Nothing contained in these rules shall adversely affect the persons holding the post on the date of issue of these rules.".
