Adhoc Rules Relating to the Temporary Posts of Personal Secretary to Hon'ble President, Superintendents and Personal Assistant (Court Work) in the State Consumer Disputes Redressal Commission Chennai / District Consumer Disputes Redressal Fora.

No. SRO B-21/2018.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on and from the 11th September 2008.

Rules

The General and the Special Rules applicable to the holders of the permanent post of Private Secretary in Class XII, category 4 of the Tamil Nadu General Service shall apply to the holders of the temporary post of Personal Secretary to the Honourable President in the State Consumer Disputes Redressal Commission sanctioned from time to time, subject to the modifications specified in the following rules:-

- 2. Constitution.- The post shall constitute a separate category in a distinct class of the said service.
- 3. Appointment.- Appointment to the post shall be made as follows:-
- (I) by promotion from among the holders of the posts of Appeal Examiner and Court Officer in the State Consumer Disputes Redressal Commission; or
- (II) by recruitment by transfer from among holders of the post of Personal Assistant in the Tamil Nadu Judicial Ministerial Service, if no suitable person is available by the above method.
- **4. Appointing Authority.-** The Appointing Authority for the post shall be the Registrar, State Consumer Disputes Redressal Commission.
- **5. Qualifications.-** No person shall be eligible for appointment to the post, unless he possesses a degree in any University recognized by the University Grants Commission.
- **6. Probation.-** Every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.
- 7. Pay.- The holder of the post shall be paid a monthly pay calculated in the Pay Band PB3 of Rs.15600 39100 with Grade Pay of Rs.5700/-.

2. The amendment hereby made shall be deemed to have come into force on the 19th September 2015.

AMENDMENT

In the said Special Rules, in part II, under the heading 'Branch I - Medical',

- 1. in rule 3, in sub-rule (a), under Class V, in category-5, for the entries in second column against the entry "Assistant Professor in Pharmaceutical Chemistry, Assistant Professor in Pharmaceutics, Assistant Professor in Pharmacognosy and Assistant Professor in Pharmacology in Government Medical Colleges" in first column, the following entries shall be substituted, namely:-
