In exercise of the powers conferred under sub-section (1) of Section 33 of Town and Country Planning Act 1971. (Act No. 35 of 1972) the Commissioner of Town and Country Planning, in proceedings Roc. No. 1464/2018/DP2, dated 19-2-2018 proposes to make the following individual draft variation for Deletion of A4A4 40'-0" wide Scheme Road, Bodinayakkanpatti Village, Survey Number 31/1pt, 2pt, 4 to the approved Suramangalam Detailed Development Plan No. 2, Salem Local Planning Area/Corporation approved by the Commissioner of Town and Country Planning's proceedings Roc. No. 30488/10 DP1, dated 3-7-2012.

2. Any person affected or interested in this draft variation may within SIXTY DAYS from the date of publication of this notification in the *Tamil Nadu Government Gazette*, can represent in person or submit in writing to the Member-Secretary, Salem Local Planning Authority any objections and suggestions relating thereto.

3. The Variation with plan may be inspected free of cost at any time during office hours at the above said Local Planning Authority Office.

VARIATION

1. Whenever the expression "Map No. 4 & 5, DDP(SR)/DTCP No. 13/2012 occurs the expression "DDP(V)/DTCP No. 1/2018 shall be added at the end and to be read with.

2. In Schedule III Part I, 40'-0" wide A4A4 Scheme Road shall be deleted.

3. In Schedule-IV (Form No. 7) in Serial No. 1 entry of A4A4 Road shall be deleted and in column No. 4; 0.73.11 hectare shall be substituted.

4. In Schedule-V, (Form No. 6) all the entries in the A4A4 40'-0" New Road shall be deleted.
