 - 2. In Schedule III Part I, 40'-0" wide A4A4 Scheme Road shall be deleted.
- 3. In Schedule-IV (Form No. 7) in Serial No. 1 entry of A4A4 Road shall be deleted and in column No. 4; 0.73.11 hectare shall be substituted.
 - 4. In Schedule-V, (Form No. 6) all the entries in the A4A4 40'-0" New Road shall be deleted.
