Draft Amendment to the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) (Tamil Nadu) Rules.

No. SRO A-21/2018.—The following draft of amendment to the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) (Tamil Nadu) Rules, 1983, which it is proposed to made in exercise of the powers conferred by sub-section (1) of Section 35 of the inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act 30 of 1979) is hereby published as required by the said sub-section (1) of Section 35 of the said Act.

2. Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of the period of one month from the date of publication of this Ntofication in the *Tamil Nadu Government Gazette*. - (a) a combined annual return in Form XIII as required in rule 42 of the Tamil Nadu Catering Establishments Rules, 1959 is furnished; or
- (b) a combined annual return in Form XII as required in sub-rule (ii) of rule 35 of the Tamil Nadu Beedi and Cigar Workers (Conditions of Employment) Rules, 1968 is furnished; or
- (c) a combined annual return in Form No. 28 as required in rule 83 of the Tamil Nadu Plantations Rules, 1968 is furnished; or
- (d) a combined annual return in Form XIX as required in rule 43 of the Tamil Nadu Motor Transport Workers Rules, 1965 is furnished".
