No. SRO/A-22/2018.—In exercise of the powers conferred by clause (k) of sub-section (2) of Section 64 of the Water (Prevention and Control of Pollution) Act, 1974 (Central Act 6 of 1974), the Governor of Tamil Nadu, after consultation with the Tamil Nadu Pollution Control Board, hereby makes the following amendment to the Tamil Nadu Water (Prevention and Control of Pollution) Rules, 1983:-

Order No. 275, Home (SC), 16th April 2018.

The following amendment is issued to the Tamil Nadu Chief Minister's Fire Service Medal Rules, made in the Government order first read above.

AMENDMENT

In the said Rules, - for Rule - 10, the following rule shall be substituted.

10. The Medal will carry a monthly allowance of Rs. 300/- per month for Fireman, Leading Firemen, Driver-Mechanic, Fireman-Mechanic, Fireman-Driver, Welder and equivalent ranks. The above allowance will be paid even if a recipient is promoted to a higher rank after the award of the medal and till his retirement.

2. The revised Medal allowance will be applicable to the recipients of Tamil Nadu Chief Minister's Fire Service Medal on the occasion of Pongal Day 2018.
