**Amendments to the Tamil Nadu Motor Vehicles Rules.***[G.O. Ms. No. 311, Home (Transport-V), 9th May 2018.]*

No. SRO A-27/2018.—In exercise of the powers conferred by Section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby, makes the following amendment to the Tamil Nadu Motor Vehicles Rules, 1989, the same having been previously published, as required by sub-section (1) of Section 212 of the said Act,-

## DRAFT AMENDMENTS

In the said Rules,-

(1) after rule 88, the following rule shall be inserted, namely:-

“88-A. Communication of Type Approval Certificates,-

(1) Every manufacturer or importer of Motor Vehicles shall file an application in FORM CTACA to the Transport Commissioner enclosing the Type Approval Certificate and the certificate as to the compliance to the provisions of the Act and these rules obtained from the agencies specified in rule 126 of Central Motor Vehicles Rules, 1989 for communicating the same to all the Registering Authorities / Assistant Registering Authorities in this State for registration of a new model vehicle or its variants:

Provided that in case of vehicles imported into India, the importer shall produce the type approval certificate issued by the approved testing agencies in the respective countries.

(2) Every application under sub-rule (1), shall be accompanied with a fee specified in the Table under rule 132.

(3) On receipt of the application under sub-rule (1), the Transport Commissioner, shall, after scrutiny of the application, issue the communication order.”;

(2) in rule 132, in THE TABLE,-

(i) serial number “1” in column (1) shall be re-numbered as “1- A”,

(ii) in columns (1) to (5), above the serial number 1-A, as so renumbered in column (1) and the entries relating thereto in columns (2) to (5), the following serial number and entries shall, respectively, be inserted, namely:-

(1) Communication of Type Approval Certificate to the Registering Authorities / Assistant Registering Authorities and granting permission for registration of each of the new base model vehicles or its variants.	10,000/- (Ten Thousand Only)	88-A	-	"; and

HOME, PROHIBITION AND EXCISE DEPARTMENT

**Amendment to the Tamil Nadu Liquor (Licence and Permit) Rules.**

[G.O. Ms. No. 30, Home, Prohibition and Excise (VIII), 7th May 2018, சித்திரை 24, விளம்பி, திருவள்ளூர் ஆண்டு-2049]

No. SRO A/28/2018.—In exercise of the powers conferred by Section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Liquor (Licence and Permit) Rules, 1981.

2. The amendment hereby made shall come into force at once.

AMENDMENT.

In the said Rules, for rule 21, the following rule shall be substituted, namely:-

"21. Renewal of licence.- A licence holder desiring to renew the licence shall make an application in the prescribed form (the same as for the original grant of the licence) alongwith payment of applicable privilege fees on or before the last day of February of the year in which the licence would expire. The application may be sent to the licensing authority directly. The provisions contained in rules 18 to 20 shall, as far as may be, apply to an application for renewal of licence as if it were an application for the original grant of a licence. Where an application for renewal of the licence has been made after the last day of February of the year in which the licence would expire, but on or before 31st March of the year in which the licence would expire, the licensing authority may admit such application, provided there are good and sufficient reasons for the delay, on payment of an additional fee of twenty-five percent of the prescribed licence fee. However, an application for renewal of licence which is received after the expiry of the licence period i.e. 31st March of the concerned year, will not be considered and the licence already granted will be deemed to be cancelled".
