**Conferment of Powers**

**No.67/2018**—In exercise of the powers conferred under Section 13 of the Criminal Procedure Code 1973, (Central Act 2 of 1974), the High Court hereby appoints the following 8 Deputy Tahsildars in Pudukottai District, 8 Deputy Tahsildars in Karur District, one Tahsildar and 6 Deputy Tahsildars in Perambalur District, 2 Tahsildars in Ariyalur District, one Tahsildar Trainee in Vellore (HQDT, Nemili Taluk), to undergo Magisterial Training for a period of 120/180 days, as the case may be, from the date of assumption of charge and confers upon them the ordinary power conferrable under this code on a Judicial Magistrate to try such cases which were earlier triable and dealt with by an erstwhile Judicial Second Class Magistrate.
