# Amendment to the Adhoc Rules for the post of Junior Co-operative Auditor in Tamil Nadu Co-operative Subordinate Service.

No.SRO B-50/2018.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of the India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules published with the Finance Department Notification No.SRO-B/149/86, published at pages 165 to 173 of Part III — Section 1 (b) of the *Tamil Nadu Governent Gazette*, dated the 16th April, 1986.

2. The amendment hereby made shall be deemed to have come into force with effect on and from the 27th January, 2010.

#### AMENDMENT

In the said Rules, in rule 8, in sub-rule (b), in the Table, for the entries in column (3) against the entry "(i) Direct recruitment" in column (2) and the corresponding entry "3. Junior Co-operative Auditor" in column (1), the following entries shall be substituted, namely:-

"Must possess B.B.M., (Bachelor of Bank Management) degree or B.Com., degree or B.Com., (Computer Application) degree or B.A. (Co-operation) degree or Diploma in Rural Services awarded by the Gandhigram Rural University or B.A. (Economics) degree or B.A. (Corporate Secretaryship) degree or B.B.E., degree awarded by any University recognized by University Grants Commission".

# Amendment to the Fundamental Rules.

[G.O. Ms. No.70, Personnel and Administrative Reforms (FR-II), 1st June 2018, வைகாசி 18, விளம்பி, திருவள்ளுவர் ஆண்டு–2049.]

No.SRO B-51/2018.-The Governor of Tamil Nadu hereby makes the following amendment to the Fundamental Rules and the instructions thereunder.

2. The amendment hereby made shall come into force on 28-04-2015.

#### AMENDMENT

In the said Fundamental Rules, in rule 56, in sub-rule (1), after clause (c) and the instruction thereunder, the following ruling shall be added, namely:-

### "Ruling.

A Government servant, who has not been permitted to retire on his reaching the date of retirement, but retained in service under clause (c), shall not be dismissed or removed or compulsorily retired from service retrospectively from the date on which he reached the date of retirement. The final order in such a case shall take effect only from the date of issue of order imposing the penalty of dismissal or removal or compulsory retirement, as the case may be."

## Amendment to the Special Rules for the Tamil Nadu Ministerial Service.

[G.O. Ms. No.71, Personnel and Administrative Reforms (B), 5th June 2018, வைகாசி 22, விளம்பி, திருவள்ளுவராண்டு–2049.]

No.SRO B-52/2018.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rles for the Tamil Nadu Ministerial Service (Section 22 in Volume-III of the Tamil Nadu Services Manual).

2. The amendment hereby made shall be deemed to have come into force on and from the 10th August 2010.

## AMENDMENT.

In the said Special Rules, in Annexure IX-E, for rule 6, the following rule shall be substituted, namely:-

"6. No person shall be eligible for appointment as Assistant by direct recruitment unless he possesses a Degree from any University recognised by the University Grants Commission".
