[Agriculture - Notification of additional units for Paddy II (Samba / Thaladi / Pishanam) - 2017 - 2018 under Pradhan Mantri Fasal Bima Yojana and Publication in the State Government Gazette - Orders - Issued.]

The following Government Order is Published:-

READ:

1. Minutes of the State Level Coordination Committee on Crop Insurance (SLCCCI) Special Meeting held on 24-7-2017 for notification of Paddy-II (S/T/P) under Pradhan Mantri Fasal Bima Yojana (PMFBY) during 2017-2018.
2. G.O.(Ms).No.209, Agriculture (AP6) Department, dated 22-8-2017.
3. Minutes of the 39th State Level Coordination Committee on 'Crop Insurance (SLCCCI) meeting held on 13-10-2017 for notification of Rabi Crops under Pradhan Mantri Fasal Bima Yojana (PMFBY) during 2017-2018.
4. From the Director of Agriculture Letter No. G1/71997/2017, dated 7-3-2018.

Order: No. 139, Agriculture (Ap2), 25th May 2018.

In the Government Order second read above, orders were issued for notifying Paddy II crop (Samba / Thaladi/ Pishanam), District wise approved premium rates for Paddy - II and Cluster wise, District wise Insurance units (Revenue Villages) during 2017-2018 under Pradhan Mantri Fasal Bima Yojana.

2. In the letter fourth read above, the Director of Agriculture has stated that the Special State Level Coordination Committee on Crop Insurance (SLCCCI) meeting was conducted on 24-07-2017 under the Chairmanship of Agricultural Production Commissioner and Principal Secretary to Government, Agriculture Department to notify Paddy II Crop during 2017-2018 under Pradhan Mantri Fasal Bima Yojana. Further, in the minutes of the 39th State Level Coordination Committee on Crop Insurance meeting held on 13-10-2017 for notification of Rabi Crops under Pradhan Mantri Fasal Bima Yojana (PMFBY) during 2017-2018, it has been informed that the Committee has finalized the insurance units and approved premium rates and accepted for notification and also permitted the Director of Agriculture to refer the subject of notifying additional Villages to the Technical Support Unit (TSU) at New Delhi. Accordingly, the Director of Agriculture addressed the Technical Support Unit regarding the notification of additional Villages. The list of additional Villages were sent to the Technical Support Unit, Government of India and the Insurance Companies. The New India Assurance Company Limited gave its consent for including the additional units of Paddy II crop during

2017-2018 while ICICI Lombard General Insurance Company Limited accepted for inclusion of all additional Villages for all crops during Rabi, 2017-2018. In continuation to this, "Go ahead" orders were issued to enrol the farmers in the additional Villages for Paddy II during 2017-2018.

3. The Director of Agriculture has, therefore, requested the Government to ratify his action in having issued "Go ahead" orders to the District Joint Directors of Agriculture for enrolling farmers in the additional units for other Paddy II crops during 2017-2018 and also to approve the additional units for notification and publication in the Government Gazette.

4. The Government, after careful examination of the proposal of the Director of Agriculture accept the same and accordingly hereby ratify his action in having issued "Go ahead" orders to the District Joint Directors of Agriculture for enrolling farmers in the additional units for Paddy II crop during 2017-2018. The Government, further, notify the additional units for Paddy II crop during 2017-2018 season under Pradhan Mantri Fasal Bima Yojana as shown in the Annexure to this order.

5. The claims under the Pradhan Mantri Fasal Bima Yojana Scheme shall be settled on the basis of yield data furnished by the Director, Department of Economics and Statistics as per prescribed cut-off dates for the notified crops / districts / firkas / revenue Villages for the effective implementation of Pradhan Mantri Fasal Bima Yojana scheme for Paddy II (Samba / Thaladi / Pishanam) season and not on the basis of the Annavari Certificate / Gazette notification declaring the area as Drought / Flood / Cyclone affected etc., by the District Collectors.
