#### CO-OPERATION, FOOD AND CONSUMER PROTECTION DEPARTMENT

#### Amendments to the Special Rules for the Tamil Nadu Co-operative Subordinate Service.

[G.O. Ms. No. 92, Co-operation, Food and Consumer Protection (CH2), 6th July 2018, ஆனி 22, விளம்பி, திருவள்ளுவர் ஆண்டு–2049.]

- No. SRO B-54/2018.—In exercise of the Powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Co-operative Subordinate Service (Section 5 in Volume III of the Tamil Nadu Services Manual, 1969).
- 2. (a) The amendment (2) (A) (i) (a) hereby made shall be deemed to have come into force on and from the 5th November 1985.
- (b) The amendments (1) and (2) (A) (ii) (c) hereby made shall be deemed to have come into force on and from the 31st August 2002.
- (c) All other amendments hereby made shall come into force on the date of publication of this Notification in the Tamil Nadu Government Gazette.

#### **AMENDMENTS**

In the said Special Rules,-

- (1) for the expressions "Steno-typist" and "Steno-typists", wherever they occur, the expressions, "Steno-typist Grade-III" and "Steno-typists Grade-III" shall, respectively, be substituted;
  - (2) in rule 2,-
  - (A) in sub-rule (a),-
  - (i) against the entry "2, Senior Inspectors" in column (1), -
    - (a) for the entries (1), (2) and (3) in column (2), the following entries shall be substituted, namely:-
    - "(1) Direct Recruitment;
    - (2) Promotion from Junior Inspectors:";
    - (b) after the entries as so substituted, the following proviso shall be added, namely:-
- "Provided that appointment to the post shall be made in the ratio of 3:1 between the direct recruitment and promotion.";
  - (ii) against the entry "3 Junior Inspectors" in column (1),-
    - (a) in the entries (1) and (2) in column (2), the word "or" shall be omitted;
    - (b) entry (3) in column (2) shall be omitted;
    - (c) after the entry (2) in column (2) the following provisos shall be added, namely:-

"Provided that the appointment to the post shall be made in the ratio of 1:3 between the direct recruitment and recruitment by transfer:

Provided further that among the Vacancies earmarked for appointment by recruitment by transfer, five percent of the Vacancies shall be filled from the category of Steno-typist Grade-III, who has put in not less than five years of service and opts for recruitment by transfer as Junior Inspector as on 1st May of the year in which the selection for appointment is made and the option so exercised shall be final";

- (iii) The 'NOTE' shall be omitted;
- (iv) sub-rule (b) and the Explanation there under shall be omitted;

- (v) for sub-rule (c), the following sub-rule shall be substituted, namely:-
- "(c) Subject to the provisions of sub-rule (b) of rule 5 all promotions to the categories of Co-operative Sub Registrars and Senior Inspectors or recruitment by transfer to the category of Junior Inspectors shall be made on the grounds of merit and ability, seniority being considered only where merit and ability are approximately equal";
  - (3) in rule 5, in sub-rule (b),-
    - (a) "in clause (i), the expressions "and computers" and "or Computors" shall be omitted.
    - (b) in clause (ii), the expression "Computors' shall be omitted.
  - (4) in rule 7, in the table,-
- (a) in serial No. (1) the expression "Computor" in column (3) against the entries "2. Senior Inspectors" in column (1) and "a) Promotion" in column (2) thereof', shall be omitted.
  - (b) in column (3) serial No.(2) and the entries thereunder shall be omitted.
- (c) for the second proviso in column 3 against the entries "3. Junior Inspectors" and "(b) Recruitment by transfer from Junior Assistants, Typists, Steno Typists employed in the Co-operative Department" in columns (1) & (2) thereof, respectively, the following provisos shall be substituted, namely:-

"Provided further that no Typist shall be eligible for appointment as Junior Inspector of Co-operative Societies, unless he has put in not less than three years on duty as Typist in the Co-operative Department:

"Provided also that with effect on and from the 2nd September 2005 no Steno Typist in Grade III shall be eligible for appointment as Junior Inspector of Co-operative Societies, unless he has put in not less than five years on duty as Steno Typist in Grade III in the Co-operative Department".

(5) in rule 9, in the "TABLE", for the expression "date of undergoing the said course of instruction and training", in column (2) against the entry entry "category (3) Junior Inspectors" in column (1) thereof, the expression" date on which he joins duty" shall be substituted.

No. SRO B-55/2018.—In exercise of the powers conferred by the proviso to Articles 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Elementary Educational Subordinate Service (Section 48A in volume-III of the Tamil Nadu Services Manual, 2016)

5. The amendments hereby made shall be deemed to have come into force on 18th May 2018.

#### **A**MENDMENTS

In the said Special Rules,

- (1) "for the expression 'Assistant Elementary Educational Officer' wharever it occurs, the expression "Block Educational Officer" shall be substituted;
- (2) "for rule 3, the following rule shall be substituted, namely:-
- 3. Appointing authority:-

The Chief Educational Officer shall be the appointing authority for the post of Block Educational Officer. The District Educational Officer of the concerned Educational district shall be the appointing authority for all the remaining classes and categories specified in these rules".

- (3) in rule 10, for sub-rules (a) and (b), the following sub-rules shall be substituted, namely:-
  - "(a) Transfer and postings of all classes in the service within the Revenue district shall be made by the Chief Educational Officer concerned. Inter Revenue District Transfer and Postings of all officers in the service shall be made by the Joint Director concerned
  - (b) Transfer and postings of all classes in the service within the Educational District shall be made by the District Educational Officer concerned."
