## NOTIFICATIONS BY GOVERNMENT

#### ANIMAL HUSBANDRY, DAIRYING AND FISHERIES DEPARTMENT

#### Amendments to the Special Rules for the Tamil Nadu Fisheries Subordinate Service

[G.O. Ms. No. 140, Animal Husbandry, Dairying and Fisheries (FS2), 19th July 2018, Aadi 3, Vilambi, Thiruvalluvar Aandu-2049.]

- No. SRO B-61/2018.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Fisheries Subordinate Service (Section 11 Part III B of the Special Rules in Volume-III of the Tamil Nadu Services Manual, 1970).
- (i) The amendments 6 (iii) and 7 hereby made shall come into force from the date of publication of the notification in the *Tamil Nadu Government Gazette*.
  - (ii) All other amendments hereby made shall be deemed to have come into force on and from the 3rd June of 2013.

#### **AMENDMENTS**

In the said Special Rules,-

- (1) in rule 1, the following entry shall be omitted, namely:-
  - "1. Research Assistant";
- (2) in rule 2, -
  - (iii) in sub-rule (a), in the Table,-
- (a) the entries "1. Research Assistant" in column (1) and the corresponding entries in column (2) thereof, shall be omitted;
- (b) for the entries in item (ii) in column (2) against the entry "2. Inspector of Fisheries" in column (1) thereof, the following entries shall be substituted, namely:-
- "(ii) Promotion from among the holders of the category of Sub-Inspector of Fisheries or in the category of Laboratory Assistant:

Provided that out of every five substantive vacancies arising in the category of Inspector of Fisheries, the first vacancy shall be filled up by direct recruitment; the second vacancy shall be filled up by promotion from Sub-Inspector of Fisheries; the third vacancy shall be filled up by direct recruitment; the fourth vacancy shall be filled up by promotion from Laboratory Assistant and the fifth vacancy shall be filled up by direct recruitment:

Provided further that if sufficient number of candidates are not available for promotion to the fourth vacancy from among the Laboratory Assistants such vacancy shall be filled up by promotion from Sub-Inspector of Fisheries.

Provided also that the vacancies arising in the category of Inspector of Fisheries shall be filled up by direct recruitment and by promotion by following the ratio 3:2 (60:40)";

- (ii) in sub- rule (b), the expression "Research Assistant", shall be omitted;
- (3) in rule 3, in the Table, under the heading "Category" in column (1), the following entry shall be omitted :-
  - "(1) Research Assistant";
- (4) in rule 4, in the Table, the following entry in item (i), shall be omitted :-
  - "Research Assistant";
- (5) in rule 5, in the Table, under the heading "Categories" in column (1), the following entry in item (1) shall be omitted:
  "Research Assistant and":
- (6) in the Annexure to rule 6, in the Table,-
- (i) the entries "1. Research Assistant" in column (1) and the corresponding entries in columns (2) and (3) thereof, shall be omitted;
- (ii) the existing entries in column (3), against the entry "2. Inspector of Fisheries" in column (1) and the entry "(ii) Promotion" in column (2) thereof, shall be re-numbered as (i);

- (iii) after the entries in (i) in column (3), against the entry "2.Inspector of Fisheries" in column (1) and the entry "(ii) Promotion" in column (2) thereof, the following entries shall be added, namely:-
- (ii) (a) Must have worked for a period of not less than five years as Laboratory Assistant in Laboratories under the Fisheries Department; and
  - (b) Must possess a first or second class degree in the subject in which recruitment is made.

Other things being equal, preference shall be given to the persons who have taken either Marine Biology or Fresh Water Biology as their special subject in their respective degree courses.":

(7) For the rule 8, the following shall be substituted:-

"No person shall be appointed to the categories of Inspector of Fisheries, Sub-Inspector of Fisheries, Foreman (Marine) and Driver (Heavy Duty Vehicles) unless he produces a security for an amount of Rs.2,000/- (Rupees Two thousand only)".

- (8) in rule 10, in the TABLE under the heading "Category" in column (1), the expression "Research Assistant" shall be omitted.
  - (9) in rule 11, the words and expression "(1) Research Assistant," shall be omitted.

# Amendments to the Special Rules for the Post of Inspector of Fisheries Revision of rules relating to Educational qualification for direct Recruitment in Tamil Nadu Fisheries Subordinate Service.

[G.O. Ms. No. 141, Animal Husbandry, Dairying and Fisheries (FS2), 19th July 2018, Aadi 3, Vilambi, Thiruvalluvar Aandu-2049.]

No. SRO B-62/2018.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for Tamil Nadu Fisheries Subordinate Service (Section 11 part III B of the Special Rules in Volume III of the Tamil Nadu Services Manual 1970).

The amendments hereby made shall come into force from the date of issue of this notification.

#### **A**MENDMENTS

In the said special rules, in the ANNEXURE to rule 6, in the TABLE,-

(a) for the items (i), (ii) and (iii) and the proviso thereunder in column (3) against the entry "(i) Direct Recruitment" in column (2) and the corresponding entry "2. Inspector of Fisheries" in column (1) thereof, the following entries shall be substituted, namely.-

"Must possess a degree of Bachelor of Fisheries Science awarded by the Tamil Nadu Fisheries University or any other University or Institution recognised by the University Grants commission.

Must possess a degree of M.Sc. in Zoology or Marine Biology or Coastal Aquaculture or Mariculture or Special Zoology or Coastal Engineering or Oceanography awarded by any University or Institution recognised by the University Grants Commission".

(b) for the entries in item (i) in column (3) against the entry "(ii) Promotion" in column (2) and the corresponding entry "2. Inspector of Fisheries" in column (1) thereof the following entries shall be substituted, namely.-

"Must have experience of not less than five years in the post of Sub-Inspector of Fisheries in the Fisheries Department".
