#### NOTIFICATION

No. SRO C-19/2018 .--

In exercise of the powers conferred by Regulation 5 of Chennai Port Trust Employees' (Recruitment, Seniority and Promotion) Regulations, 2008, the Port Trust Board *vide* its Resolution No. 14, dated 25-05-2018 has approved the amendments made to the existing Recruitment Rules for the post of Mazdoor (Civil & Project) and its promotional posts viz. Asst. Maistry (C&P), Maistry (C&P) and Head Maistry (C&P) which have been re-designated as Basic Tradesman (Junior), Basic Tradesman, Tradesman and Tradesman (Senior) respectively in the Civil Engineering Department as per recommendations of One Man Committee headed by Shri D.K. Afzulpurkar communicated by the Ministry of Shipping in its letter No. LB-11021/11/2007-L, Dated 09-06-2014.

In exercise of the powers conferred by sub-section (1)(a) of 132 of the Major Port Trusts Act, 1963 (38 of 1963), under Schedule-II of the Chennai Port Trust Employees' (Recruitment, Seniority and Promotion) Regulations 2008, the following amendments made to the existing Recruitment Rules for the Post of Mazdoor (Civil & Project) and its promotional posts in the Civil Engineering Department is cause for publication.

#### Amendments

(i) In the said Schedule-II under the said Regulations, the words "Mazdoor (C&P)" appearing in the Recruitment Rules at SI. No. 62 and 63 in the Civil Engineering Department has been substituted as "Basic Tradesman (Junior)".

(ii) In the said Schedule-II under the said Regulations, the Recruitment Rules for the post of "Mazdoor (C&P) at SI. No. 63 in the Civil Engineering Department, the entries under Column No. 8 shall be substituted by the following:-

"Must have passed 8th Standard.

**NOTE:** The qualification regarding experience is relaxable at the discretion of the Chairman in the case of candidates belonging to Scheduled Castes and Scheduled Tribes if at any stage of Selection, the Chairman is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them."

(iii) In the said Schedule-II under the said Regulations, the words "Asst. Maistry (C&P)" appearing in the Recruitment Rules at SI. No. 17 and 62 in the Civil Engineering Department has been substituted as "Basic Tradesman".

(iv) In the said Schedule-II under the said Regulations, words "Maistry (C&P)" appearing in the Recruitment Rules at SI.No. 16 and 17 in the Civil Engineering Department has been substituted as "Tradesman ".

(v) In the said Schedule-II under the said Regulations, the words "Head Maistry (C&P)" appearing in the Recruitment Rules at SI.No. 16 in the Civil Engineering Department has been substituted as "Tradesman (Senior)".

Foot Note: The Recruitment Rules in respect of Class II, III and IV posts of all the departments of the Trust included in the Schedule-II of the Chennai Port Trust Employees' (Recruitment, Seniority and Promotion) Regulations 2008 was published in the *Tamil Nadu Government Gazette vide* SRO C- 2/2016, dated 22nd May 2015.

#### JUDICIAL NOTIFICATIONS

### Amendment to Rule 4 of the Rules in regulate the Public Interest Litigations filed under Article 226 of the Constitution of India.

#### (R.O.C. No. 5232-A/2018/F1)

No. SRO C-20/2018 .--

By virtue of Article 225 of the Constitution of India and of all other powers hereunto enabling, the High Court makes the following amendment to Rule 4 of the Rules to regulate the Public Interest Litigations filed under Article 226 of the Constitution of India as published in *Tamil Nadu Government Gazette*, Part III—Section 2, Issue No.31, dated 11-08-2010.

AMENDMENT:-After Rule 4 of Rules to Regulate Public Interest Litigations framed by the High Court, the following shall be added:

"4(a) - The petitioner shall file a photo copy of a document having Petitioner's proof of identity in the form of Passport, PAN Card, Driving Licence, Aadhar Card, Photo affixed Ration Card/Family Card, Photo Identity Card issued by the employer in case of an Officer/ Employee of the Government, Government Company, Government undertaking, Statutory Authority, Public Company Limited by Shares, Employees of High Court and other Courts. A photo copy of one such document duly attested by the Officer of the Court shall be filed along with the Writ Petition."
