Amendments to the Adhoc Rules in respect of Officers of the Co-operative Audit Department.

No. SRO B-69/2018.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the adhoc rules published with the Finance Department Notification No. S.R.O.B -222/87, dated the 26th June 1987, at pages 294 to 298 of Part III-Section I(b) of the *Tamil Nadu Government Gazette*, dated the 22nd July 1987.

2. The amendments hereby made shall be deemed to have come into force on the 14th June 1994.

AMENDMENTS

In the said Rules.

- (1) in rule 6, in sub-rule (b), in the Table, in clause (b), against the post 2. Assistant Director of Co-operative Audit" in column (1) and the method of appointment "(ii) Recruitment by transfer" in column (2) thereof, for the entry "(ii) Departmental Test for Officers of the Co-operative Department in Co-operation, Auditing, Book-keeping and Banking and Rural Economics conducted by the Tamil Nadu Public Service Commission" in column (3), the following entry shall be substituted, namely:-
- "(ii) Departmental Test for Officers of the Co-operative Department in Co-operation, Auditing, Banking, Co-operative Management and Administration and Book-keeping conducted by the Tamil Nadu Public Service Commission;";

Amendment to the Special Rules for the Tamil Nadu Secretariat Service

No. SRO B-70/2018.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Secretariat Service (Section 29 in Volume III of the Tamil Nadu Services Manual, 2016):-

2. The amendment hereby made shall be deemed to have come into force on the 1st December 2014.

No. SRO B-71/2018.— In exercise of the powers conferred by the proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Public Service Commission Regulations, 1954 (Volume-I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 1st March 1995.

AMENDMENT

In the said Regulations, in ANNEXURE I-A referred to in clause (b) of regulation 16, under the heading "A. STATE SERVICES", for the entry, "2. Law Officers in the City and muffasal including the Chief Assistant State Prosecutor, the Assistant State Prosecutor in the City of Madras and the Assistant Public Prosecutors, Grades I and II in the Tamil Nadu General Service", the following entry shall be substituted, namely:-

2. Assistant Public Prosecutor, Grade-I in the Tamil Nadu General Service".
