Under Chapter IV, Section 23 sub-section (5) of the Thiruvalluvar University Act, 2002 (Tamil Nadu Act 32 of 2002), **Two Members** to the **Syndicate** by the Teachers of Affiliated Colleges of this University (other than Principals) from among themselves who are members of the Academic Council are to be elected in accordance with the system of proportional representation by means of the single transferable Vote.
