No. SRO B-93/2018.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules published with the Health and Family Planning Department Notification SRO No. A-514 of 1969 published at page 529 of Part V of the *Fort. St. George Gazette*, dated the 13th August 1969.

AMENDMENTS.

In the said Rules,-in rule 4, for sub-rule (b) the following sub-rule shall be substituted, namely:-

Amendments to the Special Rules for the Tamil Nadu Information Technology Service.

No. SRO B-94/2018.—In exercise of powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Information Technology Service (Section 52 in volume II of Tamil Nadu Services Manual 2016):-

AMENDMENTS

In the said Rules,-

(1) in rule 6,-

- (a) in the first proviso, for the expression "if he has not completed or will complete 32 years of age", the expression, "if he has not completed or will not complete 32 years of age" shall be substituted;
- (b) in the second proviso, for the expression "if he has not completed or will complete 35 years of age", the expression, "if he has not completed or will not complete 35 years of age" shall be substituted;

- (2) in rule 7, in THE TABLE,-
- (a) under the Category "4 (a) Assistant System Engineer" in column (3), against the entry "(i) By Direct Recruitment" in column (2) thereof,-
- (i) in item (a), for the expression "as main subjects from any recognized University," the expression, "as main subjects from any University or Institution recognized by the University Grants Commission or Institution recognized by the Government" shall be substituted:
- (ii) in item (b), for the expression "and Higher Secondary Certificate (HSC) (Class 12) and Qualifying Degree or Post Graduate Degree with,-" the expression, "and Higher Secondary Certificate (HSC) (Class 12) or Senior Secondary Certificate (SSC) and B.E.,/B.Tech., Degree with,-" shall be substituted;
- (b) under the Category "4(b) Assistant System Analyst" in column (3) against the entry "(i) By Direct Recruitment" in column (2) thereof,-
 - (i) in item (a),-
- I. for the expression "or Information Technology as main subject from any recognized University" the expression, "or Information Technology as main subject from any University or Institution recognized by the University Grants Commission or Institution recognized by the Government" shall be substituted;
- II. for the expression "should have a Bachelor degree in Science or Mathematics from any University", the expression, "should have a Bachelor Degree in Science or Mathematics or Computer Application from any University" shall be substituted;
- (ii) in item (b), for the expression "and Higher Secondary Certificate (HSC) (Class 12) and Qualifying Degree or Post Graduate Degree with,-" the expression, "and Higher Secondary Certificate (HSC) (Class 12) or Senior Secondary Certificate (SSC) and B.E.,/B.Tech., or B.Sc.,/B.C.A., degree and Post Graduate Degree as the case may be with,-" shall be substituted.
