Aadhaar Requirement: Amma Two Wheeler Scheme of Government of Tamil Nadu.

1. Tamil Nadu Corporation for Development of Women Limited has decided to use Aadhaar Number of the beneficiaries for the new scheme of Government of Tamil Nadu called "Amma Two Wheeler Scheme" (ATWS).
2. Beneficiaries who are in possession of Aadhaar Card, shall register the Aadhaar Number towards their enrollment to the newly implemented scheme called as "Amma Two Wheeler Scheme" (ATWS).
3. The use of Aadhaar of the beneficiaries for the new scheme implemented by Tamil Nadu Corporation for Development of Women Limited will result in accuracy of the beneficiary's details. This will also help in ascertaining identities of the beneficiaries at the grass root level.
4. Applicants who are not yet enrolled for Aadhaar are hereby requested to apply in any Aadhaar enrolment Centre/Permanent Enrollment Centre to get enrolled for Aadhaar.
5. Those beneficiaries who have enrolled for Aadhaar and have not received Aadhaar should register the 28 digit Aadhaar enrolment ID printed on the Aadhaar enrolment slip.
6. Department of Rural Development, Government of Tamil Nadu through Tamil Nadu Corporation for Development of Women Limited (TNCDW Ltd.) will inorganically seed the Aadhaar number for its beneficiaries.
7. The above provisions shall be applicable in all Districts of Tamil Nadu.
