Amendment to Adhoc Rules relating to the Temporary Post of Assistant Director in Government Data Centre in Tamil Nadu General Service.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules published with the Finance Department Notification No. SRO B-181/95, dated the 3rd August 1995, published on page 200 of Part III—Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 6th September 1995.

AMENDMENT

No. SRO B-12/2018.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Medical Services (Section 21 in Volume II of the Tamil Nadu Services Manual, 2016).

AMENDMENT

In the said Special Rules, in Part II, under the heading 'Branch I- Medical',-

- (1) in the Annexure [referred to in rule 8 (c)], for the entries in column (2) against the entries "Class X Dieticians in Government Hospitals" in column (1) thereof, the following entries shall be substituted, namely:-
- "(i) Must possess M.Sc degree in Food service Management and Dietetics or Foods and Nutrition or Food Science and Nutrition or Home Science with Nutrition and Dietetics as major or Home Science Emerging Technology, Food Service Management and Dietetics from any recognised University approved by the University Grants Commission:

Provided that the candidate must also possess their Bachelor's degree in the same subject or with the following subjects as majors during their bachelor's degree course:

- (a) Nutrition / Clinical Nutrition; or
- (b) Dietetics; or
- (c) Food Service Management.
- (ii) Previous practical experience for a period not less than two years in Multi Speciality Hospital (minimum 100 beds strength) under the supervision of a qualified, experienced senior Dietician:"
