1. Against the entry I(a) PRIMARY use zone for the expression 237 to 246, The expression 237, 238, 239/(except 239/3A2) shall be substituted and against the entry.

2. Against the entry I(b) Mixed Residential zone, after the expression Kancheepuram Municipality, Vishnukanchi 'A' Village, S.No.239/3A2 shall be added.
