Notice is hereby given that an election by postal voting is to be held for electing One Professor to the Senate of the Tamil Nadu Dr. M.G.R. (5) Nomination papers will be taken up for scrutiny at 4.45 p.m. on **05-03-2018**

(6) List of valid nominations will be published at 5.30 p.m. on **05-03-2018** in the University premises.

(7) Notice of withdrawal of candidates may be made as per the General Statutes of the Tamil Nadu Dr. M.G.R. Medical University on or before 3.00 p.m. on **12-03-2018**

(8) List of final valid nominations will be published in the University premises at 5.30 p.m. on **12-03-2018**. A copy of final valid nomination and the final list of voters will be despatched to the candidates.

9) A numbered declaration paper, a ballot paper with the name of the candidates bearing on it, the Returning Officer's initials, a cover for sending Ballot Paper and an envelope containing the address of the Returning Officer will be sent to the address entered against the name of the voter in the final electoral roll through the Heads of the Institutions / College in which he/she is working, on **22-03-2018** (Thursday). No Ballot Paper will be issued in the office to the voters on the day of election. The cover containing the ballot paper and the declaration form in the envelope be sent by Registered Post, so as to reach the Registrar/Returning Officer not later than 4.00 p.m. on **06-04-2018** (Friday) the day fixed for poll.

(10) The Voter may, either in person or by an agent, deposit the envelope addresses to the Returning Officer in the ballot box provided for the purpose at the office of the Returning Officer till **4.00 P.M. on 06-04-2018 (Friday)**.

(11) Scrutiny and counting of votes and declaration of results will be from 10.30 a.m. on 09-4-2018 (Monday) till the process is over.

NOTE:

1. The intimation of valid nominations would be sent to the candidates with a copy of the notification of the programme for the election containing last date of withdrawal and date of despatching the ballot paper to the Returning Officer by post, etc.

2. If the number of candidates, who are validly nominated and who have not withdrawn their candidates in the manner prescribed and within the time specified, does not exceed or is less than the number of vacancies to be filled, such candidate shall be declared to be duly elected.
